1. Proclamation of Commendation for Eagle Scout Charles William Heil, III for the clearing of a trail in Chase Farms and construction of bat houses and signage.

Mayor Gatt presented the proclamation to Eagle Scout Charles William Heil, III. Mr. Heil was glad to become an Eagle Scout and to help out his subdivision, Chase Farms. He said the trails are now better and safer for residents.

2. Proclamation to Proclaim August 13, 2013 as Novi Cheesecake Day.

Mayor Gatt proclaims August 13, 2013 as Novi Cheesecake Day and noted he had given the proclamation to the Founder of the Cheesecake Factory Restaurant on Friday, August 9, 2013.

 - a. Introduction of Lauren Royston, Economic Development Director

City Manager Pearson introduced Lauren Royston, Economic Development Director. She worked with the State of Michigan in their Workforce Development Programs and served Macomb County with their economic development efforts. She is a Novi

resident. Ms. Royston said this is her third week working for the City of Novi. It has been a great experience so far. She is excited to work with Novi businesses to build partnerships, as well as, bring new opportunities to Novi.

2. ATTORNEY - None

AUDIENCE COMMENT:

Connie Varana, Village Oaks resident, requested information about the ordinance regulating fireworks and was concerned about the hours, which are from 8 a.m. until midnight the eve of, the day of, and the day after a national holiday.

John Garbacik thinks item 3 on the agenda gives the City authority far beyond the title of the policy. His concern was related to trails and easements. The walkable Novi Master Plan has all subdivisions designed to be connected to the M-5 bike path by neighborhood connectors. The intention is not to use paths along the arterial roads. Established subdivisions are built without neighborhood connectors and the neighborhood connectors have to be built over existing properties. By designating connectors as a trail, it can be installed between homes as long as there is a drainage or utility easement available. There is no policy for a trail to be a certain distance from a home in existing neighborhoods. The size, slope, maintenance, and hours of operation of the trails should be predetermined prior to the implementation of the proposed policy.

November 5, 2013 general election, pursuant to recommendation from the Ad Hoc Charter Review Committee.

Mayor Gatt said the Ad Hoc Charter Review Committee has done a lot of work. On the Committee were Council Member Casey, Council Member Wrobel, City Manager Pearson, City Clerk Cornelius, City Attorney Schultz, Intern John McCarter, Mayor Gatt, former Mayor Landry, and Mr. Fil Superfisky.

Mayor Landry noted the last time the City Charter was reviewed was in 1977. It was originally adopted in 1969. In March of 2013, Council created the Charter Review Committee to identify any language that should be revised or updated. They reviewed the entire Charter. They identified nineteen suggested changes to the Charter. The Committee ranked the changes and limited five questions to go to the voters. Each question on the ballot is limited to 100 words and must be approved by the Governor's Office and Novi City Council. The changes requested update the Charter to present operations because of technological changes and to provide efficiency. Question one, on the ballot, would give the Charter gender neutral wording. The Attorney General's Office required questions two and three to be broken into two questions. Questions two and three affect City publications. There are six sections in the Charter that require notices. The Charter language would include the internet as a means of communication for notices. There is State Law that supersedes requirements for notices of ordinance changes and public hearings. Question four would combine two sections 4.13 and 4.6 because of duplicate language. It also clarifies language in section 4.6 as to who is an appointed officer. Another aspect of the question is about combining departments if it is needed. The City Manager and Council would have the ability to create a department. Question five would eliminate Section 8.10 of the Charter. The section references the warrant system that is presently in place. Warrant systems are no longer used by cities to do payables and the safeguard of it is illusory. It is an inefficient process. Also, the Charter presently requires that all funds withdrawn by the Treasury must be paid by check and signed by two officers. Currently, many of the payments done are wire transfers, P Cards and credit cards. He hopes that the additional fourteen suggested changes the Committee made would be reviewed next year.

Member Fischer thought all changes made sense but had one question about section 8.10, Withdrawal of Funds. His concern was if there was some kind of payment terms when vendors are demanding payment. City Manager Pearson said there would be a schedule established at the beginning of each year. Member Fischer didn't want employees wasting time cutting special checks all the time. City Manager Pearson said it will allow them not to have to cut special checks because it will give the vendor a better answer as to when they will be paid. It will allow the City to meet vendor terms to avoid penalties and take advantage of discounts. Member Fischer said he supports all five questions.

City Manager Pearson said they are dedicating additional dollars to Neighborhood Road work. Through the budget process, they are able to allocate additional monies towards this work to get it done as soon as possible.

Member Mutch asked when the work will take place with additional funds. Director of Public Services Hayes answered it would begin mid to late September with residents being informed in advanced.

3. Consideration of a Policy for Non-regulatory Directional and Informational Signage Guidelines for Signage within the Public Right-of-Way.

City Manager Pearson said this item was a follow-up to discussion from last Council meeting. The discussion was how the City was approaching informational signage that is not required. This Policy was developed for non-regulatory signage. It acknowledges what it does and doesn't cover. They found it appropriate, next to existing City property and utilities, signs can be placed in the Public Right-of-Way and signs for the

regional trails which are defined in the Non-Motorized Master Plan. He appreciated any feedback.

Member Casey thanked the Administration for preparing the Policy. She felt that the 30 day notice to property owners in the notification section was sufficient time but didn't understand why Council was given the same amount of time. She was open to discussion of this issue because she didn't think it was enough time for Council to review the signage before presented to the residents.

City Manager Pearson said he didn't see any problem and said it made sense about the time necessary to review.

Member Fischer cannot support this due to concern over the number of signs going up in the City. He did like, in the Policy, the elimination of signs on residential type roads. This Policy still gives the ability to put signs to public facilities such as the Library and Park which are not necessarily needed. The approach shouldn't be through a blanket policy but a comprehensive plan would make more sense.

Member Mutch will support the Policy as presented even though he had some concerns. He liked the public notification process but he didn't feel that Council should have to approve every sign request that doesn't fit within the proposed policy structure. He doesn't think it would be the best use of Council's time. He is willing to accept it to put in place a framework for them to make decisions. In terms of the scope, he thought the Policy was too restrictive. He cited items such as natural beauty roads which we have signage on that indicated that they are natural beauty roads or scenic drives which under our current policy, the signs would not be allowed. Some of the signage that is currently allowed or in place would have to be removed. He explained that there are other examples. He understood the objections to signage in the subdivisions. The Policy makes it more restrictive than what is intended. He was surprised with the concerns about the signage in the City because there is a lot of information and directional signage already in place. We may not be aware of it. A number of the signs could be affected by a change in the policy. The signs currently exist and this concern resulted in the bike route signs. He feels there are signs for everything but people are not comfortable putting up signs for bicycle riders or pedestrians. He would like a balance to meet all the needs of all people who are utilizing a roadway. The public comments have led to changes. It was mentioned previously that neighborhood connectors are not regional trails. Regional trails are the ITC Corridor and M-5. He doesn't read this policy as allowing signage outside the two corridors without going through the approval process. Also, it is his understanding that it is strictly limited to easements owned by utilities. He didn't read where either of those aspects of the Policy applied to the situation that Mr. Garbacik referred to. Mr. Garbacik brought up a good point for neighborhood connectors and it will be discussed at the Walkable Novi Committee meeting. They should look at what standards should be in place for the neighborhood connectors. As future development comes forward, he finds the current standards are insufficient.

Member Margolis supports this policy. She thanked Administration for generating the Policy. The biggest concern was when the signs appeared on people's lawns. She could see the concern and the Policy addresses that concern.
