#### **BACKGROUND INFORMATION:**

This case involves a roughly 9.7-acre parcel of property on the north side of 12 Mile just east of the Oakland Hills Memorial Cemetery and adjacent to the Americana Foundation property. The front roughly one-third of the parcel is zoned for OS-1 office use, consistent with the master plan for future land use. The balance of the property is zoned RA, residential acreage, and is master planned for quasi-public use.

In January, 2005, the City Council denied an application for rezoning of the entire property to RM-1, low-density, low-rise multiple-family residential, with a Planned Rezoning Overlay (PRO) for 64 residential units. The applicant then sought a use variance for the same development from the Zoning Board of Appeals, which denied the request in May, 2005. The property owner filed a lawsuit in the Oakland County Circuit Court challenging the rezoning denial. The City has been discussing with the property owner a consent judgment allowing on the entire parcel (including the area now zoned RA) the uses permitted in the OS-1, OS-2, and OS-C (except hotels, motels, and hospitals) districts, with an increased height limitation of 46 feet/3 stories, a slightly smaller parking lot setback, and a funeral home/mortuary use as a use permitted as of right rather than a special land use.

The attached consent judgment sets forth such a resolution.




