BACKGROUND INFORMATION:

In June 2007, the City of Novi contracted with McNish Sporting Goods to provide youth and adult travel soccer uniforms. McNish Sporting Goods has provided satisfactory service, high quality merchandise and fulfilled orders in a timely manner.

The original contract consists of one year with two annual renewal options. Based on performance and customer satisfaction, staff recommends approval of the first renewal option which extends the existing agreement through June 30, 2009 for youth and adult travel soccer uniforms with McNish Sporting Goods.
