BACKGROUND INFORMATION:

In an effort to upgrade and streamline the efficiency of this service, all municipal generator locations and equipment are combined into one contract. Precision Generator can also provide backup power to the Novi Ice Arena in the case of a power outage. With this contract the City will have a single vendor who is responsible for all maintenance, emergency repair, and also able to provide an emergency generator if the need arises. The contract period is for one (1) year, with two (2) renewal options in one (1) year increments.


