#### **BACKGROUND INFORMATION:**

Dunnabeck Court meets the City's defacto street criteria (streets located in platted subdivisions that did not previously go through the City's formal dedication/acceptance process). This street was always intended for City acceptance. The City would receive approximately \$374 annually from Act 51 funding for maintaining .163 miles of roadway.


