BACKGROUND INFORMATION:

In 2006, the City of Novi and its consultant, Orchard Hiltz & McCliment, reviewed each of the city's 15 sanitary pump station sites as part of the Capacity Management Operations and Maintenance Study Phase II and provided recommendations for future projects, such as this one. The purpose of this project is to upgrade two existing sanitary pump stations: Bellagio Lift Station located on Beck Road south of Nine Mile Road; and Napier Lift Station is located on Island Lake Drive (south of 12 Mile Road and east of Napier Road). The locations are shown on the attached map.

The scope includes the installation of a generator at both sites and several upgrades to Bellagio lift station including new higher capacity pumps to serve the build-out flows, safety improvements and replacement of corroded galvanized equipment with stainless steel.

Six bids were received and opened on February 19, 2009 following a public bid solicitation period. The low bidder is Man Con Michigan, Inc. Man Con's bid is recommended as being in the best interest of the City as it is responsive (i.e., Man Con has complied with all requirements of the bidding instructions) and it is the lowest price. (OHM's award recommendation letter dated February 23, 2009 is attached). A summary of the six accepted bids is as follows:

Man Con has worked in Novi most recently on the Stonehenge and Country Place Lift Station Improvements. The have received satisfactory recommendations from references and have 23 years of experience.

It is anticipated that the work will be completed by fall 2009.

On February 19, 2009 at 2:00 pm, bids were received for the above referenced project. We received a total of six (6) bids. The results for the bids are summarized below:

Our Engineer's Opinion of Cost for this project was \$208,000.00. The project scope consists of furnishing all materials, equipment, and labor necessary for the improvements at the Bellagio and Napier Sanitary Lift Stations. The work consists of the replacement of the submersible pumping equipment and controls at Bellagio and the addition of natural gas generators at both the Bellagio and Napier stations in accordance with the plans and specifications.

Man Con Michigan Inc. out of Shelby Township, Michigan is the apparent low bidder on this project. They have 23 years of experience and have sufficient bonding capacity for this project. They have received satisfactory recommendations from references that have them currently under contract or who have worked with them recently. Additionally, we note that

Man Con Michigan Inc. completed the pump station work for the City of Novi at the Country Place and Stonehenge Pump Stations in 2008. The work there was completed satisfactorily and it is our understanding that the City was satisfied with the work.

Based on our findings, we recommend award of this contract to Man Con Michigan Inc. in the amount of \$211,000.00 based on the lump sum bid amount.
