BACKGROUND INFORMATION:

Department of Public Services staff continues to work with Oakland County Health Division officials to identify mosquito habitats to prevent the West Nile Virus. By participating in the County's program, the Field Operations Division has been effectively treating catch basins and standing water areas with chemical pesticide briquettes. The briquettes are distributed twice a year (March and August); each application is effective for 150 days.

County health officials continue to emphasize the importance of public education on mosquito control, early source reduction, and strong personal protection measures. City staff promotes awareness on Channel 13, the website, homeowner association newsletters/meetings, and Fall for Novi with an International Flair.

The Oakland County Board of Commissioners has approved this year's reimbursement for West Nile Virus expenses incurred by cities, towns and villages (CVT). Each qualifying CVT receives funds according to a formula established by the County (75% for population/25% for total square miles).

Last year the City of Novi was reimbursed \$18,612. Oakland County has cut CVT reimbursement by 40% for this season's applications. In addition to this years reimbursable funding of \$11,515, the city has supplies on hand that will complete the 2009 program.

City Clerk Maryanne Cornelius Whereas, the Oakland County Board of Commissioners has established a West Nile Virus Fund Program to assist Oakland County cities, villages, and townships in addressing mosquito control activities; and,

Whereas, Oakland County's West Nile Virus Fund Program authorizes Oakland County cities, villages, and townships to apply for reimbursement of expenses incurred in connection with mosquito protection activities, mosquito habitat eradication, mosquito larviciding or focused adult mosquito insecticide spraying; and.

Whereas, the City of Novi will be incurring expenses in connection with mosquito control activities; and,

Whereas, the City of Novi is compliant with Oakland County's 2009 Mosquito Smarts Program and is eligible for reimbursement under Oakland County's West Nile Virus Fund Program,

Now, Therefore, Be It Resolved, that the Novi City Council authorizes the Department of Public Services, Field Operations Senior Manager, Matt Wiktorowski, as agent for the City of Novi, to request reimbursement for mosquito control activities under Oakland County's West Nile Virus Fund Program.

PROCEDURES FOR REIMBURSEMENT FROM THE WEST NILE VIRUS FUND

The City, Village, or Township (CVT) shall submit all correspondence to:

Timothy J. Soave, Manager, Oakland County Fiscal Services Division Executive Office Building, Third Floor West 2100 Pontiac Lake Rd Waterford, MI 48328

1. In order to obtain reimbursement form the West Nile Virus Fund, for eligible expenses, each CVT shall submit the following to the address above:

a. Due by May 1, 2009:

Project expense reimbursement request which states the project purpose and scope, estimated or actual costs, including any support detail, to insure compliance with Board of Commissioner approved policies for the West Nile Virus Fund and is otherwise authorized by law.

b. Due by August 15, 2009:

A resolution authorizing the reimbursement request adopted by the CVT's legislative board or council.

a. Due by September 15, 2009:

Documentation of actual cost borne by the CVT in conjunction with the project plan once work is completed. Note: A CVT may request pre-project authorization (requesting an allocation prior to completion of work. If a CVT requests pre-project authorization, invoices of actual cost are to be submitted once work is completed).

- 2. The Fiscal Services Division will notify the Health Division of the receipt of the project plan and/or reimbursement request. The Health Division shall determine if the plan/reimbursement request complies with Board of Commissioner approved policies for the West Nile Virus Fund and is otherwise authorized by law.
- 3. Upon receipt of Health Division approval, the Fiscal Services Division shall notify the County Commissioner(s) representing a CVT of receipt of the reimbursement request. Fiscal Services shall process the reimbursement request and recommend to the General Government and Finance Committees of the Board of Commissioners the approval of a disbursement request that is supported by an existing Board of Commissioner appropriation and meets the requirements of law and this resolution.
- 4. Recognizing that Michigan law imposes differing voting requirements for authorizing County financial participation in projects eligible for reimbursement under this resolution, no CVT shall receive any disbursement for the West Nile Virus Fund until their authorized request has been approved for disbursement by the Board of Commissioners, via a resolution sponsored by the Commissioner(s) representing the CVT and adopted by the affirmative voting margin required by law.
- 5. If project pre-approval is used, upon approval by the Board of Commissioners, the CVT shall direct all requests for reimbursement of amounts expended or to be expended by the CVT in connection with project expenses eligible for reimbursement to the Fiscal Services Division. The Fiscal Services Division will then process the reimbursement request.

Any undisbursed amount(s) remaining after September 30, 2009 except where authorized through a preproject authorization application filed not later than August 1, 2009, shall be maintained in the West Nile Virus Fund until finally distributed according to subsequent Board action. In the event that the West Nile Virus Fund is closed, any remaining fund balance shall be transferred to the General Fund.
