SUBJECT: Adoption of resolution to rename Fonda Drive as Crescent Boulevard in anticipation of the future Northwest Quadrant Ring Road project.

BACKGROUND INFORMATION:

The Northwest Quadrant Ring Road project, which is currently in its final design phase, involves the construction of a new road extending west from Novi Road along the existing Fonda road segment, and then southwesterly to Grand River Avenue. Once constructed, this new road segment would be considered an extension of the existing Crescent Boulevard which extends east from Novi Road. A location map has been enclosed for reference.

Currently there is one building that has a Fonda address (Shirvanian Office Building, an owner-occupied business). There are two vacant parcels that could redevelop in the future. The Engineering Division has initiated the street name change now so that the new street name could be included in the Road Commission for Oakland County project to upgrade the traffic signals to decorative mast arms (to be completed in spring 2010), and to limit the inconvenience associated with an address change in the future should the other Fonda parcels develop.

The owner of the Shirvanian Office Building is aware of the intention to change the name of the road and has no objection. Street names are changed by resolution of City Council pursuant to Section 31-53 of the City Code. Pursuant to Section 31-51 of the City Code, this road name change has been approved by the Street Naming Committee (see Angie Pawlowski letter dated September 18, 2009).

RECOMMENDED ACTION: Approval of resolution to rename Fonda as Crescent Boulevard in anticipation of the future Northwest Quadrant Ring Road project.


