### BACKGROUND INFORMATION:

The Road Commission for Oakland County (RCOC) is working on the final details of the construction plans for the Novi Road Link project which includes the widening of Novi Road to five lanes between Ten Mile Road and Main Street along with a bridge over the CSX railroad. The attached information provides more detail about the size and location of the requested temporary construction easement, which includes approximately 0.2 acres along a 10 foot wide area adjacent to Novi Road and a 30 foot by 150 foot area at the northeast corner of the parcel. The temporary construction easement is needed for grading associated with the relocation of Gen-Mar Drive, which is required to facilitate the construction of the new bridge.

RCOC is finalizing the right-of-way agreement with CSX railroad and working to finalize the remaining easements required before bidding the project for construction. The current schedule includes an August 2010 bid letting with construction of the temporary roads, water main and utilities to being in September 2010. The bridge work and road construction would begin in spring 2011 with a final completion at the end of 2011.

**RECOMMENDED ACTION:** Approval to grant a temporary construction easement to the Road Commission for Oakland County for the construction of the Novi Road Link project (Ten Mile Road to Main Street) on parcel 22-22-400-027, a vacant parcel on Novi Road.

#### TEMPORARY EASEMENT

KNOW ALL PERSONS that the City of Novi ("Grantor"), a municipal corporation, whose address is 45175 West Ten Mile Road, Novi, MI 48375, hereby grants to the BOARD OF COUNTY ROAD COMMISSIONERS OF THE COUNTY OF OAKLAND ("Board"), State of Michigan, a public body corporate, located at 31001 Lahser Road, Beverly Hills, Michigan 48025, an easement for a temporary period of time ("Temporary Easement") in the construction of Novi Road ("Project"), being Project Number 41531, at the following described premises ("Property") situated in the City of Novi, County of Oakland, State of Michigan.

Commonly known as: vacant (Part of) Tax Parcel No.: 22-22-400-027

#### SEE PARCEL DRAWING, ATTACHED AS EXHIBIT "A," AND DESCRIPTION ATTACHED AS EXHIBIT "B" WHICH IS INCORPORATED BY REFERENCE HEREIN

This Temporary Easement is conveyed for the sum of \$1.00 (one dollar) and shall expire at the completion of the Project. The purpose of this Temporary Easement is to grant to the Board the right to move workers, equipment, and materials on, over, and through the Property and to store equipment, material, and excavated matter on the Property. This Temporary Easement includes, but is not limited to, the consent of the Grantor to the removal of any trees, shrubs, and/or vegetation, to grading, to the temporary occupancy of the Property by public utilities, and to other matters which, in the sole discretion of the Board, may be necessary in connection with the Project. Grantor waives further notice of such actions.

The permission stated in this Temporary Easement shall begin on the date the Project begins and shall end on the date the Project is completed. The work described above shall be constructed and/or restored, as may be applicable in the sole discretion of the Board, in a workmanlike manner and in accordance with applicable state and county standards. Upon completion of the work described above, the Board and its agents shall have no further or ongoing responsibilities in relation to the work described.

This Temporary Easement runs with the land and shall bind the Grantor and the Grantor's heirs, representatives, successors, and assigns. This Temporary Easement contains the entire understanding of the Grantor and the Board, and there are no other verbal promises between the Grantor and the Board except as shown herein.

WHEREFORE, upon approval by the Board, the undersigned Grantor hereby creates, confirms, and conveys the Temporary Easement described herein.




