SUBJECT: Approval of form of deed for dedication of right-of-way of city owned property within The Landings site to provide 60-foot wide dedicated rights-of-way for portions of South Lake Drive and East Lake Drive.

CITY MANAGER APPROVAL

BACKGROUND INFORMATION:

The City Council adopted several resolutions on March 22, 2010 vacating the existing rights-of-way for unimproved or "paper" streets located on city-owned property at the southeast corner of Walled Lake. An additional action is needed to identify and designate the right-of-way for East Lake Drive and South Lake Drive through the cityowned property. The enclosed guit claim deeds and accompanying legal descriptions have been developed to dedicate a 60-foot wide right-of-way along East Lake Drive and South Lake Drive.

The form of quit claim deed was prepared by the City Attorney and the legal descriptions were prepared by for the city by Orchard, Hiltz and McCliment and reviewed by the Engineering Division.

RECOMMENDED ACTION: Approval of form of deed for dedication of right-of-way of city owned property within The Landings site to provide 60-foot wide dedicated rights-of-way for portions of South Lake Drive and East Lake Drive.




