BACKGROUND INFORMATION:

The purpose of this project is to upgrade two existing sanitary pump stations: Drakes Bay Pump Station located on Wixom Road at Drakes Bay Drive, and Park Place Pump Station located on Nine Mile at Roberts Road. The locations are shown on the attached map. This project was recommended by the second phase of the Capacity Management Operations and Maintenance (CMOM) Study completed in 2006 and includes the installation of an emergency generator at each site, along with several upgrades to each site including safety improvements and select replacement of equipment and controls.

Five bids were received and opened on May 26, 2010 following a public bid solicitation period. The lowest bidder is Matzak, Inc. Matzak's bid is recommended as being in the best interest of the City as it is responsive (i.e., Matzak has complied with all requirements of the bidding instructions) and it is the lowest price. (SDA's award recommendation letter including the bid tabulation dated May 27, 2010 is attached). A summary of the five bids is as follows:

Matzak successfully completed the West Oaks Regional Detention Basin Improvements project in 2009.

The approved project budget is \$277,000 of which \$13,553 was awarded for design engineering in January 2010, \$164,519 is recommended for award to Matzak for construction, and \$24,146 is recommended for award to SDA for construction engineering services (a separate item on this agenda) for total contract awards in the amount of \$202,218.

The construction contract award is also being considered elsewhere on this agenda. Construction is scheduled in August 2010 (after the equipment which has long lead times has been delivered to the site) and completion is anticipated in September 2010.

RECOMMENDED ACTION: Approval to award a construction contract for the 2010 Sanitary Pump Station Upgrade project, to Matzak, Inc., the low bidder, in the amount of \$164,519.



On May 26 at 3:00 pm, construction bids were opened and publicly read at the City of Novi for the 2010 Sanitary Pump Station Upgrades project.

The City Clerk's office received five (5) bids for this project. The apparent low bidder, Matzak Inc., submitted a bid price of \$176,819.00 for construction of this project (\$164,519.00 excluding Crew Days). Subsequent to the bid opening, Spalding DeDecker Associates (SDA) reviewed all of the bids received and prepared the attached bid tabulation for the project.

Submitted unit prices were reviewed against those being currently seen in the construction industry. SDA believes the unit prices are within an acceptable range for this type of work. SDA has also reviewed contractor qualifications and a list of references from Matzak Inc. Based upon our review of the submitted qualifications and a check of the references, SDA finds that Matzak Inc. is qualified to perform the required construction.

It is our recommendation that the project be awarded to the low bidder, Matzak Inc., for the 2010 Sanitary Pump Station Upgrades project. Upon award by the City Council our office will coordinate the execution of the Contract Agreement, Bonds and Insurance Policy as well as any other necessary documents with the selected contractor, and issuance of a Notice to Proceed upon execution of the contract documents.
