SUBJECT: Approval to award an amendment to the engineering services agreement with Spalding DeDecker Associates (SDA) for construction engineering services related to Fuerst Park Phase 1 improvements project in the amount of \$13,611.

BACKGROUND INFORMATION:

Spalding DeDecker Associates (SDA) provided construction engineering services for the Fuerst Park Phase 1 Improvements including contract administration and construction inspection services. SDA's original contract amount of \$13,800 was awarded administratively in March 2009. The award was made prior to implementation of the current fee structure for public projects; therefore, the fee structure was based on the private development fee template (see attached) and a construction value of \$198,000. The awarded fee was 7.0% of the construction value. The fee was awarded prior to construction award so SDA could assist with bidding the project. After the award to SDA, additional phases were added to the construction project for Fuerst Park increasing the construction value of \$330,981.97 at the time of award to WCI in April 2009 and a final construction value of \$397,474.37 at the time of final payment (a separate item on this agenda).

SDA has submitted a request for additional fees in the amount of \$13,611 for bidding services, contract administration, and construction inspection services associated with the added construction scope (SDA's December 10, 2010 letter is attached). Staff has reviewed the request and recommends the award of \$13,611. The total value of the construction engineering services contract with SDA would be \$27,411, or 6.9% of the construction value.

RECOMMENDED ACTION: Approval to award an amendment to the engineering services agreement with Spalding DeDecker Associates (SDA) for construction engineering services related to Fuerst Park Phase 1 improvements project in the amount of \$13,611.
