SUBJECT: Approval of Traffic Control Order 12-20 requiring eastbound Calvert Isle Drive to yield to Amesburg Drive.

BACKGROUND INFORMATION:

A request was received from a resident that lives near the intersection of Calvert Isle Drive and Amesburg Drive to review the intersection because it lacks a yield sign or stop sign. Engineering staff reviewed the stamping set for Island Lake Phase 5B and noted that a yield sign on Calvert Isle Drive at Amesburg Drive was shown on the approved site plan. A field review by Engineering staff confirmed that a yield sign would be appropriate at this intersection based on existing sight distance. The installation of the yield sign has been scheduled and will be completed by DPS Field Operations staff.

There is no existing traffic control order for the yield sign, therefore staff recommends approval of Traffic Control Order 12-20 requiring eastbound Calvert Isle Drive to yield at Amesburg Drive.


Dear Mr. Coburn,
