BACKGROUND INFORMATION:

The acceptance of Citygate as a public street is proposed for City Council consideration elsewhere on this agenda. Citygate was constructed as part of the USA 2 GO gas station site plan under a Planned Rezoning Overlay (PRO) agreement with Novi Mile, LLC. The approved site plan for the USA 2 GO included the installation of a stop sign for westbound Citygate at Beck Road (see attached map). Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs that have been installed on public streets. Therefore, staff has reviewed the installation of the traffic control sign and has prepared the attached traffic control order for consideration by City Council.
