BACKGROUND INFORMATION:

This project included the reconstruction and rehabilitation of Beck Road between Nine Mile Road and Cheltenham Drive. This section of road was rated a PASER 3 (poor). The portion between Nine Mile Road and Beckenham Boulevard was reconstructed while the remaining portion, between Beckenham Boulevard and Cheltenham Drive was repaved using mill and overlay. Some drainage improvements were also performed in the reconstructed area where the road had experienced flooding in the past. The project also included 4-foot wide paved shoulders within the project limits as recommended by the Non-Motorized Master Plan. The construction contract was awarded to Florence Cement Company at the June 6, 2011 City Council meeting in the amount of \$314,365. The design plans were developed and the construction contract administered by the City's engineering consultant, Spalding DeDecker & Associates, Inc. (SDA).


Engineering staff and the Spalding DeDecker reviewed and verified the final contract payment amount of \$16,533.70 that is due to the contractor, Florence Cement Company. (Final Pay Estimate No. 3, attached). The City Attorney has reviewed the documentation and found it to be in an acceptable form (Beth Saarela's September 10, 2012 letter, attached).

There were two approved change orders resulting in a net increase of \$16,308.49 to the construction contract price. The first change order, in the amount of \$14,450, was approved to address several unforeseen issues not known until excavation took place. The second change order, in the amount of \$1,858.49, was primarily to balance quantities originally estimated in the contract. The sum of approved change orders resulted in a final contract price of \$330,674.09.

RECOMMENDED ACTION: Approval of the final pay estimate to Florence Cement Company for the Beck Road Rehabilitation project (Nine Mile Road to Cheltenham Drive) in the amount of \$16,534.
