BACKGROUND INFORMATION:

Acceptance of the streets within Andelina Ridge Phase 2 is being presented for City Council consideration elsewhere on this agenda. The approved site plan for the development includes the installation of traffic control devices, such as yield signs and no parking signs.

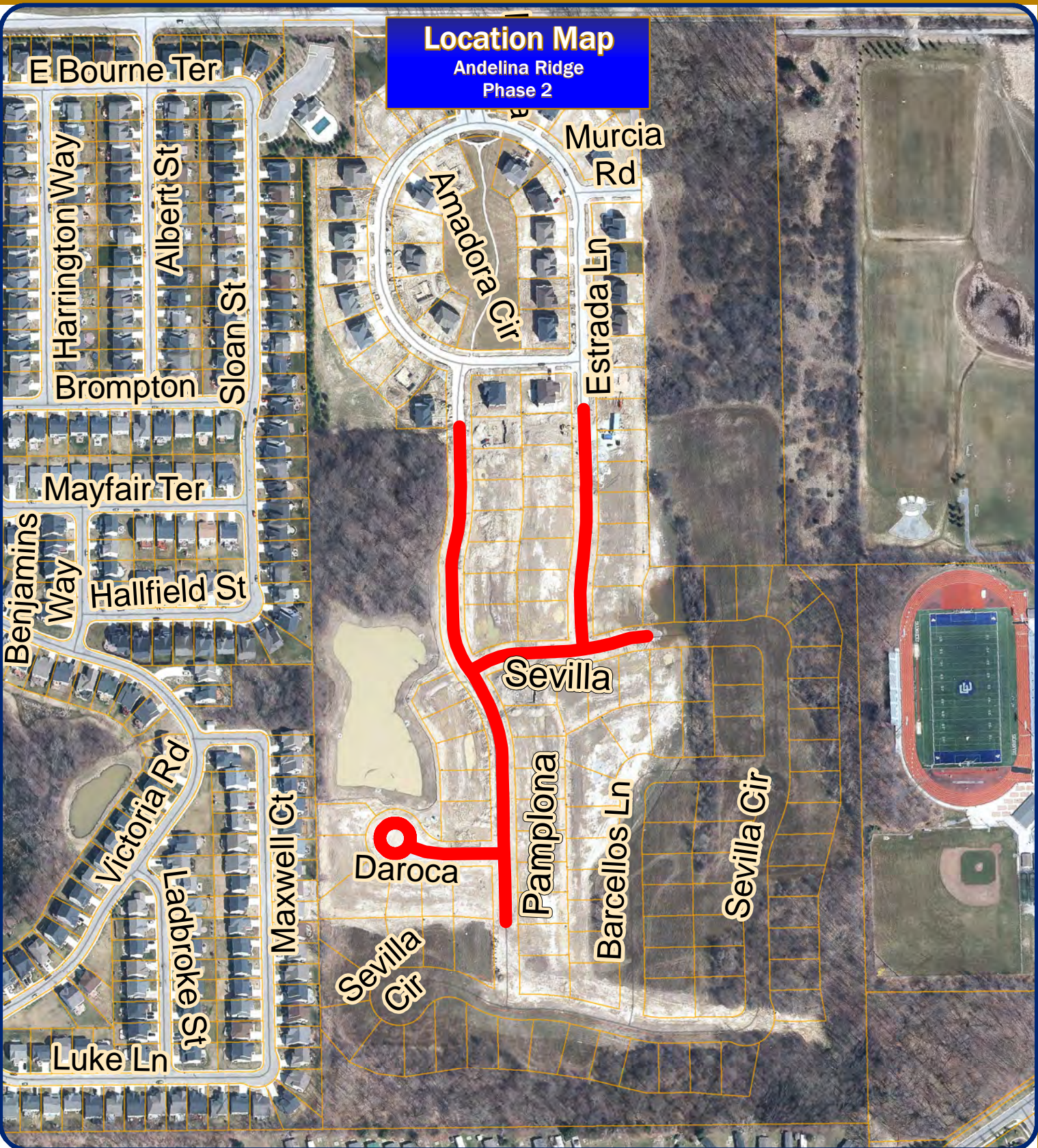
Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs that have been installed on public streets. Therefore, staff has reviewed the installation of the traffic control signs and has prepared the following traffic control orders for approval by City Council.

TCO No.	Description
17-35	Eastbound Daroca to yield at Pamplona
17-36	No Parking on Eastbound Daroca (north side of cul-de-sac island)
17-37	No Parking on Westbound Daroca (north side of cul-de-sac island)
17-38	No Parking on Eastbound Daroca (south side of cul-de-sac island)
17-39	No Parking on Westbound Daroca (south side of cul-de-sac island)
17-40	Southbound Estrada to yield at Sevilla
17-41	Westbound Sevilla to yield at Pamplona

Phase 2

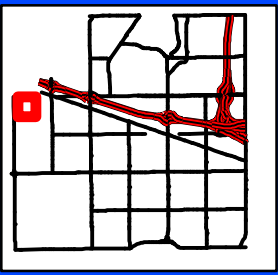
