SUBJECT: Approval to temporarily assign Precinct 8 from Meadowbrook Elementary, 29000 Meadowbrook Road to Crosspointe Meadows Church, 29200 Meadowbrook Road and Precinct 12 from Hickory Woods Elementary, 30655 Novi Road to Maple Manor, 31215 Novi Road for the August 5, 2014 Primary Election due to summer construction by Walled Lake Consolidated Schools.

BACKGROUND INFORMATION: The City Charter prescribes in Section 3.1 that the City Council shall fix the location of the polling places.

Precincts 8 and 12 must be temporarily moved due to summer construction by the Walled Lake Consolidated Schools. Precinct 8 is normally situated at the Meadowbrook Elementary, 29200 Meadowbrook Road and Precinct 12 is normally located at Hickory Woods Elementary, 30655 Novi Road. The Walled Lake School District contacted the City of Novi to explain that both elementary schools will be completely closed and no entry is allowed other than for construction workers.

We have contracted with Crosspointe Meadows Church, 29000 Meadowbrook Road, Novi, MI 48377 to host Precinct 8 and Maple Manor, 31215 Novi Road, Novi, MI 48377 to host Precinct 12. We will notify every voter affected in each of these precincts by U. S. Mail, press release, legal ad, social media and the City's website.

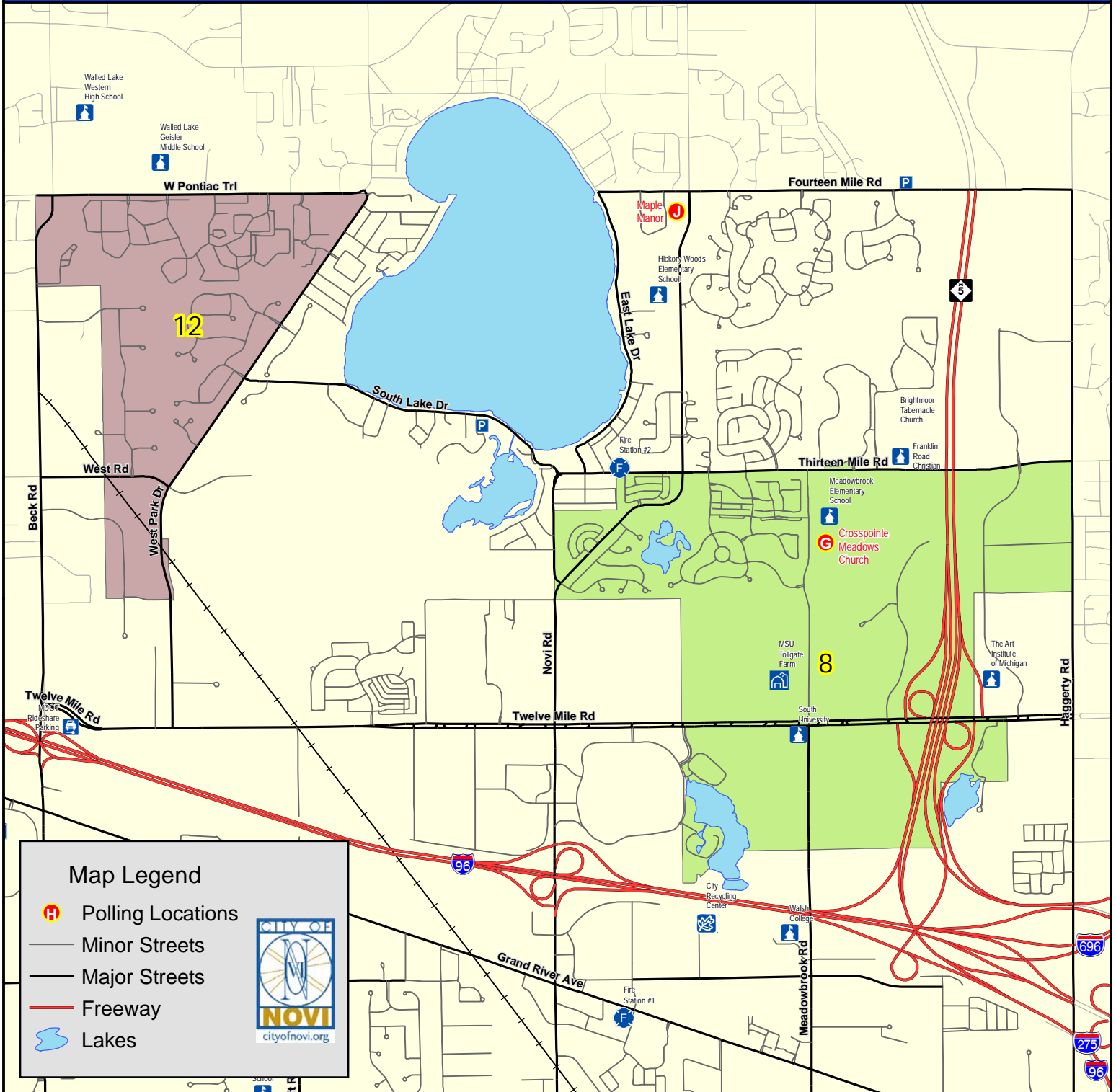

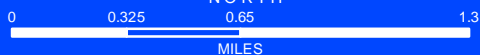
