SUBJECT: Approval of a Resolution of Support for a transportation enhancement grant application for the construction of a non-motorized pathway on the north side of Nine Mile Road between Meadowbrook and Haggerty Roads.

BACKGROUND INFORMATION:

The Michigan Department of Transportation's Transportation Enhancement (TE) Grant Program has been identified as a potential source of funding for pathway projects. During FY08/09 budget discussions, a mixed use (e.g., bicycle and pedestrian) pathway on the north side of Nine Mile Road between Meadowbrook and Haggerty Roads was selected as a candidate project. As shown on the attached figure, pathway gaps totaling approximately 3,500 linear feet exist on the north side of Nine Mile Road.

As part of the application process, letters and resolutions of support are required from various entities. Thus far, we have received the attached letters of support from:

- Southeast Michigan Council of Governments (SEMCOG)
- Oakland County Trails Advisory Council
- Walkable Novi Committee

The attached Resolution of Support recognizes the importance of this project to the city's overall non-motorized pathway network, and to the regional non-motorized pathway system because of the connectivity that will be made to the nearby I-275 bike path.

The grant application proposes a 40% local match from Novi (currently estimated to be \$97,000). The minimum local match amount is 20%; however, according to MDOT's TE program manager successful grant applications typically propose matches higher than the minimum.

To minimize disturbance to residents and potentially realize cost savings, construction of the Nine Mile Road pathway project will be completed concurrent with reconstruction of Nine Mile's roadway, which is now slated for FY 2011/2012. (As presented on the attached page from the FY 08/09 CIP, the roadway project will receive grant funding from the State in FY 12/13 but the earliest it can be constructed is FY 11/12.)

RECOMMENDED ACTION: Approval of a Resolution of Support for a transportation enhancement grant application for the construction of a non-motorized pathway on the north side of Nine Mile Road between Meadowbrook and Haggerty Roads.



SEMCOG supports the proposed project that links into the I-275 Regional Bicycle Trail along Nine Mile. On behalf of the Oakland County Trails Advisory Council (OTAC), I am writing to express our support for the Michigan Department of Transportation (MDOT)-Transportation Enhancement Grant request being submitted by the City of Novi. This grant would provide the necessary funding to complete a 0.7 mile segment of shared use path that would provide several neighborhoods access to the nearby commercial district along Haggerty Road and to the regional I-275 Bike Path.

The OTAC is an organization whose goal is to assist in the planning, development, and maintenance of a complete non-motorized countywide trail network for the citizens and visitors of Oakland County. As part of our goal, we recently completed a comprehensive Trails Master Plan for Oakland County. The City of Novi plays a key role in our overall goal of creating an interconnected trail and pathway network throughout the county and the region. 

At the September 10th City Council meeting, Council directed administration to gather more information in regard to applying for a Transportation Enhancement (TE) grant for the construction of a sidewalk along Nine Mile Road between I-laggerty and Meadowbrook Roads. To clarify the issue, there are two pathway projects planned for this segment: a 5-foot wide pedestrian sidewalk on the north side and an 8-foot wide bike path on the south side of Nine Mile. (Please note that the Capital Improvement Program lists Project No. 40 as an "8 Foot Pathway North Side"; however, it should have read "South Side" because of the higher priority assigned and the fact that 8-foot wide pathways are master-planned for the south side of all mile roads.) These two projects are summarized in the following table:

From the 2006 Pathway and Sidewalk Prioritization and Analysis Report

As background, in 2000 Council canceled a TE grant project that would have added a sidewalk on the south side of Nine Mile from Haggerty to Novi Road. Several comments were received from Nine Mile area residents who were opposed to the project. Most of the objections came from residents of Sunrise, Whispering Meadows and Turtle Creek subdivisions who they felt that putting a sidewalk on adjacent berms (which are entirely in the City's 60-foot half right-of-way) would be unsafe and pose security issues.

Compared to the south side project, the lower priority north side project has several advantages in terms of construction and cost, including:

- No bermed areas;
- Shorter distance/lower cost; and,
- More curbed areas to allow the path to be constructed closer to the road where mature trees interfere with normal alignment.

The north side project's alignment includes five unplatted parcels; therefore additional right-of-way may have to be acquired if there is not sufficient room inside of the City's statutory 33-foot wide half right-of-way.

Concerning the TE grant, the application process is very straightforward and the forms can be completed via the State's website. It is important to note two key items: 1) the grant requires a 20% local match; and, 2) MDOT requires all pathways to be mixed use, which means they must be ten feet wide to meet American Association of State Highway Transportation Officials (AASHTO) standards.



At that time, if Council is in agreement with proceeding with the north side project, we would apply for the TF grant next year in anticipation of receiving funding for construction in late 2008 or early 2009 (depending on when grant funding is made available following award).

Transportation Enhancement Program

Program Background

- The Transportation Enhancement (TE) program was established with passage of the federal Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991, reauthorized in 1998 in the Transportation Equity Act for the 21st Century (TEA-21), and again in 2005 under the Safe, Accountable, Elexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU).
- The TE program is a 10 percent set-aside of Surface Transportation Program (STP) funds.
- The TE set-aside from Michigan's STP allocation is about \$20-\$25 million annually.
- The TE program is administered by the Office of Transportation Economic Development and Enhancement (TEDE) of the Michigan Department of Transportation (MDOT).

Eligible Activities

SAFETEA-LU specifies the following 12 activities as eligible for TE program funding:

Nonmotorized Transportation

- Provision of facilities for pedestrians and bicycles
- Preservation of abandoned railway corridors (Including the conversion and use thereof for pedestrian or bievele trails)
- Provision of safety and educational activities for pedestrians and bicyclists

Transportation Aesthetics

- · Landscaping and other scenic beautification
- Acquisition of scenic easements and scenic or historic sites, including historic battlefields
- Inventory, control and removal of outdoor advertising
- Scenie or historic highway programs (including the provision of tourist and welcome center facilities)

Historic Preservation

- Historic preservation
- · Archaeological planning and research
- Establishment of transportation museums
- Rehabilitation and operation of historic transportation buildings, structures, or facilities (including historic railroad facilities and canals)

Water Quality & Wildlife

 Environmental mitigation to address water pollution due to highway runoff or reduce vehiclecaused wildlife mortality while maintaining habitat continuity

Program Requirements

- Eligible applicants include county road commissions, cities, villages, transit agencies, MDOT,
 Native American tribes, the Michigan Department of Natural Resources, and metropolitan planning organizations. Other organizations may sponsor applications.
- TE funding requires matching funds of at least 20% of project cost.
- Proposed TE projects must have a relationship to surface transportation.
