SUBJECT: Approval to award an amendment to the engineering services contract for construction engineering related to the West Oaks Regional Detention Basin Improvements project, to Spalding DeDecker & Associates, Inc., for a fee equal to 7.3% of construction costs, or \$7,290.55.

BACKGROUND INFORMATION:

The purpose of this project is to repair and improve the West Oaks Regional Detention Basin located on City property adjacent to Donelson Drive in the southwest portion of the West Oaks shopping center, which serves the majority of the shopping center. The basin is maintained by the City of Novi, and was identified as a high priority improvement in the 2007 Storm Water Master Plan Phase II.

Spalding DeDecker was awarded the design engineering component of this project on January 26, 2009. As part of the original request for proposals, the Engineering Department required the consultants to provide construction phase fees to facilitate the later award of the construction phase. Of the four firms that submitted proposals, Spalding DeDecker had the highest staff review score, met all requirements listed in the request for proposals and had the most comprehensive proposal.

Spalding DeDecker's proposal included a construction engineering fee of 7.3% of construction costs which is being considered for award now that construction bids have been received and actual construction costs are known. The construction engineering fee to be awarded is \$7,290.55 based on the 7.3% of the construction bid price of \$99,870.50 (Spalding DeDecker's fee proposal from the referenced contract is attached).

The construction contract award is also being considered on the June 15, 2009 agenda. Construction is scheduled to begin in July 2009 and completion is anticipated by August/September.

RECOMMENDED ACTION: Approval to award an amendment to the engineering services contract for construction engineering related to the West Oaks Regional Detention Basin Improvements project, to Spalding DeDecker & Associates, Inc., for a fee equal to 7.3% of construction costs, or \$7,290.55.
