SUBJECT: Acceptance of a warranty deed from Providence Hospital and Medical Centers, Inc. for the dedication of additional right-of-way along Grand River Avenue as part of the Providence Hospital Expansion project located at 47601 Grand River Avenue (parcel 22-17-400-035) and approval to execute a Quit Claim Deed conveying the additional dedicated right-of-way to Oakland County.

SUBMITTING DEPARTMENT: Department of Public Services, Engineering Division BTC

BACKGROUND INFORMATION:
Providence Hospital and Medical Centers, Inc. is requesting acceptance of a Warranty Deed conveying an additional variable width of right-of-way (a maximum of 15.82 feet wide) for the south side of Grand River Avenue along the frontage of the Providence Hospital site. Providence Hospital is located on the southwest corner of Grand River Avenue and Beck Road, at 47601 Grand River Avenue (parcel 22-17-400-035).

Grand River Avenue is under the jurisdiction of the Road Commission for Oakland County, therefore upon acceptance of the right-of-way from the property owner, the City should execute the enclosed Quit Claim Deed to convey the right-of-way to Oakland County.

The enclosed Warranty Deed has been favorably reviewed by the City Attorney (Beth Kudla's November 11, 2010 letter, attached) and is recommended for approval. The enclosed Quit Claim Deed has been prepared by the City Attorney and is also recommended for approval.

RECOMMENDED ACTION: Acceptance of a warranty deed from Providence Hospital and Medical Centers, Inc. for the dedication of additional right-of-way along Grand River Avenue as part of the Providence Hospital Expansion project located at 47601 Grand River Avenue (parcel 22-17-400-035) and approval to execute a Quit Claim Deed conveying the additional dedicated right-of-way to Oakland County.

Dear Mr. Staup:
We previously reviewed and approved the Warranty Deed conveying the Grand River right-of-way adjacent to the Providence Hospital campus to the City. A copy of the Warranty Deed is enclosed. Because Grand River is a county road, the City should accept the right-of-way from Providence Hospital and Medical Centers and convey it to Oakland County by quit claim deed. We have prepared the enclosed Quit Claim Deed from the City to the RCOC for this purpose.

Upon City Council's acceptance of the Grand River Road right-of-way, the City should record the original Warranty Deed from Providence Hospital and Medical Centers to the City with the Oakland County Register of Deeds. The original Warranty Deed was provided to the City Clerk's Office with our letter dated, November 5, 2010.

At the time of acceptance of the right-of-way, City Council may also approve conveyance of the Quit Claim Deed conveying the Grand River Road right-of-way from the City to the RCOC. Once approved and executed by the City, the original Quit Claim Deed should be returned to my attention and I will follow-up with the Right-of-Way Department at the RCOC to complete the County's acceptance of the Quit Claim Deed.
