SUBJECT: Approval to award a construction contract for the Fuerst Park Irrigation Improvements project to H2O Irrigation, Inc., the low bidder, in the amount of \$44,960.

BACKGROUND INFORMATION:

This project includes a portion of the second phase of the development of Fuerst Park, approved in the FY2010-11 Capital Improvement Program. Johnson Hill Land Ethics Studio (JHLE) assisted staff with the design and layout of the park irrigation and lighting components of Fuerst Park Phase 2. The park lighting project is being proposed for award as a separate contract elsewhere on this agenda.

This contract includes the installation of irrigation of the remaining areas of Fuerst Park in accordance with Hamilton Anderson's concept plan for the park's development. The project was split into several areas as reflected by the base bid and alternates (see attached map). This was done to maximize the area to be irrigated given the current budget. Based on the below bids received, all of the alternates are being recommended for award.

Nine (9) bids were received and opened on March 24, 2011 following a public bid solicitation period. The lowest bidder is H2O Irrigation, Inc. (H2O). H2O's bid is recommended as being in the best interest of the City as it is responsive (i.e., H2O has complied with all requirements of the bidding instructions) and it is the lowest price. (JHLE's award recommendation letter including the bid tabulation dated March 28, 2011 is attached.) A summary of the nine bids is as follows:

The contract administration and construction inspection for this project will be completed by DPS Engineering Division staff (for a total savings of approximately \$7,900 on this project for services typically provided by consultants).

The project was included in the FY2010-11 capital improvement program in the budgeted amount of \$323,000, of which \$44,960 is now being recommended for award to MHM for installation of the irrigation.


Construction is scheduled to begin in May 2011 and completion is anticipated by June 2011.



On March 24, 2011 at 3:00 p.m. construction bids were opened and publicly read aloud at the City of Novi Civic Center for the Fuerst Park Phase 2 Underground Irrigation Improvements.

The City Clerk's office received nine (9) sealed bids for this project. The bid form included a base bid for irrigating the hill area located directly behind the amphitheater (Areas A and B) and alternate bids for the remainder of the park (Areas C, D, and E). Following the bid opening, Johnson Hill Land Ethics Studio reviewed all bids and prepared the attached Bid Tabulation.

H2O Irrigation, Inc. submitted the lowest base bid and the lowest overall bid (including all alternates). No errors were found in their bid. In addition, references were checked and representatives from past projects were contacted. All were very complimentary of the work that H2O had completed for them.

We therefore recommend that the City of Novi consider that the bid submitted by H2O Irrigation, Inc. to be the lowest responsible bid received and further, that they consider awarding a contract to H2O Irrigation, Inc. for the base bid amount plus all alternate bid items for a the total contract amount of \$44,960.00.

Upon award by the City Council, our office will coordinate the completion of the Contract Agreement, Bonds and Insurance information with H2O Irrigation, Inc., and issue the Notice to Proceed upon execution of the contract documents.
