SUBJECT: Approval to award a change order in the amount of \$15,963 to Camtronics, Inc., the City's video technology vendor, for the addition of three video cameras at the Field Services Complex.

BACKGROUND INFORMATION:

In August 2009, the Police Department installed a video camera system at the Field Services Complex (FSC) as part of a digital technology upgrade to the Police Department's camera system and to provide surveillance of the gun range. As part of the contract, two cameras were installed at that time. To provide full coverage of the entire FSC, three additional cameras are needed:

- Main Gate Camera One camera to be installed on the northwest corner of the main DPS building's garage to view the main gate.
- Gas Pump Cameras Two cameras to be installed near the southeast corner of the main DPS building to view the north side of the fuel island, and on the northeast corner of the storage building to view the south side of the fuel island.

Having video surveillance of these areas is critical, not only because of the millions of dollars worth of equipment stored at the FSC, but also because of the need to safeguard the City's fuel supply, which costs the City nearly \$34,000 per month on average.

The need for video surveillance is further justified by the fact that the City will be increasing the level of shared services with other communities, meaning that more non-City employees will be on-site.


For the FY 2011-12 Budget, City Council approved \$9,500 for the purchase of the three video cameras to be located at the FSC. The projected cost of this service improvement was based on a 2009 quote, which failed to take into account specific camera locations and their associated cost requirements. The City is leveraging existing underground conduit but, is upgrading the connectivity through the use of fiber optic cabling to provide higher access speeds and reduce future connectivity issues. The proposed volume of data collected by the three new cameras will require the addition of two hard

drives in the existing master recorder. The current price from the City's vendor, Camtronics, is \$15,963, including labor for installation.

RECOMMENDED ACTION: Approval to award a change order in the amount of \$15,963 to Camtronics, Inc., the City's video technology vendor, for the addition of three video cameras at the Field Services Complex.

As requested, here is the quote to add three cameras to the Novi DPW yard. This project includes the installation of low voltage and fiber optic cabling which will connect the new security cameras to the existing video system.

Project Scope:

Provide and install three new security cameras to be connected to the existing system. Fiber optic cabling will be installed between the main building and the south storage building through existing underground conduit. Fiber optic transceivers will be installed for video transmission. Low voltage cabling will be installed for two out of the three cameras which will complete the camera wiring. Two new hard drives will be installed in the existing master recorder along with three cameras licenses. Work includes configuration of the new cameras.

Warranty: one year parts and labor.

New camera positions:

1) On main building to watch the main gate

2) On main building to watch north side of gas pumps

3) On storage building to watch south side of gas pumps

A.C. Power provided by others. Underground conduit is assumed good and without obstructions.
