The following information is an overview of the Administrative Report to the Parks, Recreation & Forestry Commission for the month of January, 2009.

# 1. Overview of the Signature Park Project and Citizen Input Opportunity

In November 2008, the Novi Community School's Board of Education and the Novi City Council unanimously approved an agreement for the land transfer of 73 acres of property located at Eleven Mile Road and Beck Road. The City envisions the creation of a Signature Park which could consist of a recreation center, (older adult, theatre, gymnasiums, recreation program space), and a variety of outdoor amenities, (soccer fields, festival area, trails). On November 24, 2008, the City contracted with the consulting team of Neumann Smith, Beckett Raeder, and Pros Consulting to create the conceptual plan for the park, including a recreation facility, and an operational feasibility study for the facility. The conceptual design and feasibility study will be completed by January 30, 2009 and will be discussed at a special City Council meeting on February 9, 2009.

The City has provided citizens the opportunity to provide input about the project through an on-line survey, e-mail, and by speaking at the January 8, 2009 Parks, Recreation & Forestry Commission meeting.

## 2. Preparation of the 2009/2010 operating budget

The FY 2009/2010 budget calendar is attached. Staff are preparing the operating budget, vehicle and capital outlay request for submittal by February 13, 2009.

## 3. Position transfer: Effective January 12, 2009

Tracie Ringle, Communications Specialist, will transfer from the Parks, Recreation & Forestry Department to the Community Relations Department. This will centralize and improve all City of Novi communications and marketing.
