Dear Board of Appeals,

Singh Homes Building Company would like to request the renewal of our temporary use permit for the Construction Trailer that is located on lot 84 Tollgate Woods Phase 2. Here is the basis of our request.

- The last renewal request was approved at the Oct. 3, 2006 ZBA meeting. Case 06-072
- The trailer is used by our field construction staff to meet contractors, city inspectors, customers and for storage of plans and misc. construction items. Currently Tollgate Woods Phase 2 has 27 vacant lots remaining.
- Singh Homes is also building in Novi at Churchill Crossing Phase 3 with 35 vacant lots remaining and Willowbrook Farms Phase 3 and 4 with 14 vacant lots remaining. Neither of these sites have a construction trailer and the trailer at Tollgate Woods is used for the construction operation of these sites as well.
- Singh Homes is requesting renewal of the temporary use permit for another two year period.
