
BACKGROUND INFORMATION:

Mill Road is a local collector south of Nine Mile Road and west of Sunrise Blvd. Nine Mile Road carries an average daily traffic of 10,000 vehicles along this segment. Mill Road Court East and Mill Road Court West intersect with Mill Road just south of Nine Mile Road, and currently there are no traffic control signs posted at this intersection. DPW Staff propose one yield sign for both eastbound Mill Road Court West at Mill Road and westbound Mill Road Court East at Mill Road. The yield signs at this intersection will call on the driver to slow down, defer to oncoming or intersecting traffic, and stop when necessary.

Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs installed on public streets. Staff has prepared the following traffic control orders for approval by City Council.

TCO No.	Description
18-11	Eastbound Mill Road Court West to yield at Mill Road
18-12	Westbound Mill Road Court East to yield at Mill Road

RECOMMENDED ACTION: Approval of Traffic Control Orders 18-11 and 18-12 for traffic control signs on Mill Road Court West and Mill Road Court East.




