CM 14-07-116 Moved by Casey, seconded by Mutch; CARRIED UNANIMOUSLY:

To approve ordinance 14-113.05 to amend the City of Novi Code of Ordinances, at Chapter 25, Parks and Recreation, in order to revise existing regulations relating to the leash requirement for dogs to create an exception for the City's dog park and to provide for the adoption of rules governing conduct in the dog park – FIRST READING.

Mr. Cardenas said this was the first reading of the rules. He added that progress was moving along, the fencing was nearly complete and access to the park will be electronic. The rules mirror the Northville dog park rules. Novi residents that want to be members of the park will have to complete an online training and will have access to the Northville dog park through a memorandum of understanding with the City of Northville. The Northville dog park rules have been in effect since 2003 and have similar characteristics and provisions as the Oakland County parks, Cities of Royal Oak, Grosse Pointe Farms and Clinton Township.

Member Casey questioned that the rules indicate dogs can enter the park with an individual who is 16 years old and older, yet the Michigan Penal Code says it must be persons 18 or older. The City Attorney will look into that prior to the second reading.
