**SUBJECT:** Approval of either Option 1, 2, or 3 for the action plan submission of the Safe Routes to School grant application.

### CITY MANAGER APPROVAL:

### **BACKGROUND INFORMATION:**

The City has collaborated with the Novi Community School District (NCSD) to solicit funding from the Michigan Safe Routes to School (SRTS) grant program. Safe Routes to School is a federally funded program designed to encourage and enable children in grades K-8 to walk and bicycle to school. Over the last year, City staff has identified seven (7) school campuses in the NCSD as potential candidates for funding: Deerfield Elementary, Parkview Elementary, Novi Woods Elementary, Novi Meadows Elementary, Orchard Hills Elementary, Village Oaks Elementary, and Novi Middle School. Each school submitted a parent and student survey about the current challenges of walking to school.

Following the surveys, a multi-agency, district-wide walking audit was completed, public meetings were held, and a presentation was given to City Council at their regular meeting on April 15, 2019. City staff is now preparing to submit the final Action Plan Estimate for the SRTS program with three recommended options for City Council to review, choose, and approve.

Potential grant awards can be up to \$200,000 per campus in infrastructure construction for a total of \$1.4M district-wide (7 school campuses). The funds can be dispersed throughout the district and are not limited to a specific campus. The revised Action Plan Estimate Totals range from \$258,000 to \$1,197,000 depending on which option is selected. There are five school campuses that do not impact any residential property owners and two school campuses that include work within neighborhoods. Exhibits for each campus are included in the packet for reference.

The cost estimates for infrastructure construction along with specific scope options are as follows:

### School campuses with no impact to neighborhoods:

Deerfield Elementary	Scope - \$5,000	
Novi Middle School	Scope - \$12,000	
Parkview Elementary	Scope - \$30,000	
Novi Meadows Elementary	Scope - \$5,000	
Novi Woods Elementary	<u> Scope - \$70,000</u>	
	Total \$122,000	

The two campus with potential neighborhood projects identified with specific scopes are outlined below. ADA upgrades and drainage work is included where necessary along all sites mentioned.

### Orchard Hills Elementary:

### Scope A - \$715,000

5,800 total feet of 5'-wide sidewalk along on both sides of Borchart Drive and Tamara Street

### Scope B - \$77,000

600 total feet of 5'-wide sidewalk along on both sides of Tamara Street from Quince Road to School Campus

#### Scope C - \$403,000

3,200 total feet of 5'-wide sidewalk along on both sides of Borchart Drive from Meadowbrook Road to Asphalt Connector Pathway\* (\*Silvery Lane and Borchart Drive)

#### Scope D - \$391,000

3,100 total feet of 5'-wide sidewalk along on both sides of Tamara Street from Meadowbrook Road to School Campus

#### Village Oaks Elementary:

#### Scope A - \$360,000

2,300 total feet of non-motorized network along Village Wood Road and Willowbrook Drive:

250 total feet of 10'-wide carriage walk along the east side of Willowbrook Drive 1,360 total feet of 5'-wide sidewalk on both sides of Village Wood Road from the east crossover to Willowbrook

650 total feet of 10'-wide pathway along the south side of Village Wood Road from Cranbrooke Drive/Village Wood Road crossover

#### Scope B – \$ 59,000

250 total feet of 10'-wide carriage (adjacent to curb) walk along the east side of Willowbrook Drive from Village Wood Road to Guilford Road

Any combination of project scope can be assembled as the grant submission option. Approval of any option is for grant submission only. Design engineering will only be initiated if the SRTS grant is awarded. The three recommended options listed below are based on public meeting input, constructability, Right-of –Way and private property construction easements.

Input at the public meetings was:

- Orchard Hills: 5 in favor, 6 opposed
- Village Oaks: 5 in favor, 9 opposed

### Option 1:

Five campuses with no neighborhood impact	\$122,000
Orchard Hills (Scope A)	\$715,000
Village Oaks (Scope B)	\$ 59,000
Total Grant Submission	\$896,000

Option 1 has the most neighborhood impact in Orchard Hills, which received reasonable support at the public meeting. Two property owners would be impacted in Village Oaks. It utilizes 65% of available grant funds.

### Option 2:

Five campuses with no neighborhood impact	\$122,000
Orchard Hills (Scope A)	\$715,000
Village Oaks (Scope A)	\$360,000
Total Grant Submission	\$1,197,000

Option 2 has the most impact in neighborhoods but maximizes grant dollars (85% of available funds).

### Option 3:

Five campuses with no neighborhood impact	\$122,000
Orchard Hills (Scope B)	\$77,000
Village Oaks (Scope B)	<u>\$ 59,000</u>
Total Grant Submission	\$258,000

Option 3 has the least impact in neighborhoods and is the least request for grant funding (less than 20% of available funds).

**RECOMMENDED ACTION:** Approval of Option \_\_\_\_\_ for the action plan submission of the Safe Routes to School grant application.

### Proposed Infrastructure Improvements

(1) Install an RRFB crossing with associated crosswalk pavement markings

(3) Remove and replace existing sidewalk ramps, at 11 Mile and Arcadia Drive, and replace with ADA compliant ramps.

### Proposed Infrastructure Improvements

(1) Install ADA crossings and 5-ft sidewalks on both sides (unless noted) of the roadway along the highlighted red portions on map:

 Willowbrook Drive from Guliford to Cranbrooke Drive
 Village Wood Road from Willowbrook Drive to Cranbrooke Drive

(2) Reconfigure crossings due to missing ADA ramp in the south west quadrant of this intersection (Guilford & Willowbrook) as an existing crosswalk dead-ends to grass
