
BACKGROUND INFORMATION:

Special Assessment District (SAD) 179 was initiated by a formal petition signed by the Meadowbrook Townhomes Condominium co-owners, Tollgate Ravines Condominium Association Board of Directors, and the owner of the Brownstones at the Vistas Apartments for the purposes of financing the reconstruction of Brownstone Drive, Hemingway Drive, Holmes Drive, Cummings Lane, and Twain Place for dedication the City pursuant to the Vistas PUD agreement and the corresponding site plans of the developments. In June 2017, the City agreed to accept the five streets contingent on their rehabilitation and financing by SAD 179. As part of the dedication to the City, the Department of Public Works will fabricate and install 4-way Stop signs at the intersections of Brownstone Drive and Holmes Road and at Brownstone Drive and Hemingway Drive, 13 Mile Road and Holmes Road, and at Brownstone Drive and Meadowbrook Road. No Parking signs will be erected along Cummings Lane and Twain Place.

Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs installed on public streets. Staff has prepared the following traffic control orders for approval by City Council.
