BACKGROUND INFORMATION: In 2020, the Southeast Michigan Council of Governments (SEMCOG) selected the City's ITC Trail to Wildlife Woods Park Pathway Connection for funding through the Tranportation Alternatives Program (TAP) grant. The project will connect an existing sidewalk south of the pavilion at Wildlife Woods Park to the existing ITC Trail, east of the park. The grant will cover \$113,609 of the estimated total construction cost of \$189,348. The City will be responsible for a 40% match, which amounts to \$75,739.

The adoption of the proposed resolution demonstrates to the Michigan Department of Transportation (MDOT), who oversees the grant, that City Council supports the project and acknowledges that the City will be responsible for the long-term maintenance of the pathway once it is constructed. The City Attorney reviewed the resolution favorably (Beth Saarela, April 8, 2021). An extension of the Wildlife Woods connector pathway to Ascension Providence is being added to this project to coincide with a pathway project Ascension Providence is undertaking this summer. The extension piece was not included in the original grant application and therefore, is not eligible for grant funds.

RECOMMENDED ACTION: Adoption of a resolution of support for the ITC Trail to Wildlife Woods Park Pathway Connection project and authorization of participation in the Transportation Alternatives program grant for non-motorized pathways.





WHEREAS ; the Novi City Council has developed and adopted a Non-Motorized Master Plan and has established as a goal to fund completion of sidewalk and pathway gaps and/or corridors using budgeted dollars and possible grant funding; and

WHEREAS ; the City of Novi identified the ITC Trail to Wildlife Woods Park Pathway project (along the south side of Wildlife Woods Park, north of Eleven Mile Road and east of Wixom Road) as a connection between the Wildlife Woods Park and the existing ITC Corridor Regional Pathway, and submitted a grant application under the Transportation Alternatives Program; and

WHEREAS ; the City of Novi was awarded a federal grant for the ITC Trail to Wildlife Woods Park Pathway project covering 60% of the project, which has a construction cost estimate of approximately \$189,348; and

WHEREAS ; the City of Novi is required to contribute 40% toward the construction of the project and said local contribution estimated to be \$113,609 is allocated in the Parks, Recreation, and Cultural Services Fund budges; and

WHEREAS ; the Michigan Department of Transportation administers all projects that receive local funds on behalf of the local agency; and

WHEREAS ; the City of Novi acknowledges that once construction of the pathway is completed it will belong to the City of Novi and that the City of Novi will be responsible for the long-term maintenance of the pathway.

NOW THEREFORE, IT IS THEREFORE RESOLVED that the Mayor and Council of the City of Novi support and authorize participation in the ITC Trail to Wildlife Woods Park Pathway project within the City of Novi.
