
BACKGROUND INFORMATION:

Taft Road from 10 Mile to Grand River was reconstructed during the summer of 2018 and included crushing the existing asphalt and converting it to a base layer, followed by the placement of two lifts (approximately six inches) of hot mix asphalt (HMA). The scope of this project also included northbound and southbound bike lanes along the project limits, which satisfies the City's Non-Motorized Master Plan.

The project also included solar-powered stop sign flasher signals at two intersections to compliment this road construction. In order to address visibility and pedestrian safety, these stop sign warning signals were installed at the intersections of Taft Road and 9 Mile Road as well as Taft Road and 11 Mile Road. The Road Commission for Oakland County (RCOC) typically maintains the City's traffic signal infrastructure.

An agreement for traffic control devices is required for each signal to be maintained by the RCOC. Pending approval and signing of the license agreement, staff will facilitate execution of the document with the RCOC and maintain a copy for City records.

RECOMMENDED ACTION: Approval of a license agreement with the Road Commission for Oakland County (RCOC) for the installation and maintenance of Solar Powered Stop Sign Flasher Signals at the intersections of Taft Road and 9 Mile Road, and Taft Road and 11 Mile Road.


