SUBJECT: Consideration of Resolution Acknowledging the Updated Multi-Year Budget Projections for Fiscal Years 2027/28 and 2028/29

SUBMITTING DEPARTMENT: City Manager

KEY HIGHLIGHTS:

- At its April 13, 2026, meeting City Council directed City staff to bring back only the finalized Fiscal Year (FY) 2026/27 annual budget at the May 4, 2026, Council meeting for adoption. Council determined that the information provided for projecting budget information the two "out" years of the usual multi-year budget, FY 2027/28 and 2028/29, should be brought back for consideration at a later date (but before the start of the new Fiscal Year).
- Staff has prepared revised information for the two out years for Council's consideration. If acceptable to the Council, a Resolution acknowledging the updated projections.
- The proposed projections, as described in the Resolution, recognize ten (10) positions--all currently open/unfilled--as being eliminated from FY 2026/27 through 2028/29.
- By the final fiscal year 2028/29, the City's fund balance is projected to be at **29%**, or **\$14.6 million**, in line with Council's direction.

BACKGROUND INFORMATION:

The recommendation for City Council's consideration is to reduce the operational or recurring expenses by (on average) **\$1.4 million** over the next three years. Not filling open positions (10 in total) that have gone unfilled for quite some time is how the city administration realizes the \$1.4 million. The ten positions reflect the actual staffing levels that the City has maintained over the last few years, rather than the anticipated or budgeted levels.

The other main area being recommended for reduction is capital expenditures. Anticipated capital expenditures (heavy-duty equipment like plow trucks, fire apparatus, building generators, network servers, software licenses, etc.) are an issue

that will need further review and action to address during the course of each budget year. In order to meet Council's stated goals, and because staff has yet to identify the resources to fund them, some larger items are being pushed past year three while keeping some of the smaller things in the proposal.

All the changes reflected in this resolution are initially shown by department, as that is how the budget is officially adopted:

The final Budget document will incorporate these changes into the fiscal year 2027-2028 and 2028-2029 projections. The 2026-2027 adopted budget will remain as adopted by the Council at the May 4, 2026, meeting. A budget amendment will be submitted to Council in July to reduce the 2026-2027 budget.

WHEREAS, the City Manager's recommended budget is based upon City Council's strategic themes and goals, along with property tax projections from the City Assessor; and

WHEREAS, the budget for Fiscal Year 2026-2027 was approved by City Council on May 4, 2026; and
