BACKGROUND INFORMATION:

The City of Novi received the attached email from the Oakland County Treasurer, which identifies foreclosed properties under Act 123 of 1999 for failure to pay taxes. Under MCL21 1 .78(M)(1), the County is given a right of first refusal, and if it does not exercise that right the City gets the next "option" to purchase the property for a "public purpose." The properties were tax foreclosed by the County's Circuit Court on February 14, 2018 and the redemption period ended on April 2, 2018. The unpaid taxes and interest total \$3.284.12, plus additional fees, charges, or other costs as determined by the County and as required by law. An aerial photograph showing the location of the property is included. The property will be utilized as right-of-way for future road projects on 12 Mile Road.

RECOMMENDED ACTION: Approval to purchase a tax-foreclosed property from Oakland County under Act 123 of 1999, parcel number 50-22-15-151-001, located in the City of Novi Section 22, for the amount of \$3,284.12 plus additional fees, charges, or other costs as determined by the County and as required by law for the property.

Below is a list of properties in your city, village or township that were property tax foreclosed by the Oakland County Circuit Court on February 14, 2018, and by the County Treasurer under Public Act 123 of 1999, as amended. The redemption period ended April 2, 2018.

In accordance with Michigan Compiled Law, Section 211.78M (1), you have a statutory right to purchase the properties on this list for the amount of the delinquent taxes, interest and fees provided you have a "public purpose" in mind in exercising this right of refusal. If property purchased by a city, village, or township is subsequently sold for an amount in excess of the minimum bid and costs incurred relating to demolition, renovation, improvements, or infrastructure development, the excess amount shall be returned to the county.

The list is sorted by parcel identification number, address, state equalized value (SEV), and amount due at the end of the redemption period, per the Circuit Court's judgment. Additional fees, interests and maintenance costs may be added so please contact the Treasurer's Office at 248-858-0615 for the correct amount.

We would also like to request that you provide our office the water bill amounts due, forecasting through the day of the auction for the parcels on the list. We will add these amounts to the minimum bid amount at the auction, and if the parcel sells we will send the amount collected back to you after the sale is completed and closed in September. Any additional information you can provide us about the properties on this list would also be greatly appreciated; i.e. condemned, not buildable, swamp land, etc.

Please notify our office in writing of your intention to purchase property for the "minimum bid" amount no later than May 25, 2018, and include a list of the properties, a copy of your Council or Board's resolution approving the purchase of the properties, and the "not more than" authorized purchase amount. No response will be considered a waiver of your right of refusal.
