#### PUBLIC HEARING: None

#### PRESENTATIONS:

 Proclamation recognizing May as Building Safety Month - Charles, Director of Community Development and Jeff Johnson, Director of Emergency Medical Services/Fire Operations

Jeff Johnson thanked Mayor and Council for the proclamation. He said that Charles Boulard had approached him and felt strongly they should continue working together to ensure everyone has a working smoke alarm and carbon monoxide detectors in their home. He said they have great teams in Community Development and in the Fire Department and they work seamlessly together. This is a great opportunity to continue the program. They want to ensure everyone has the ability to have a working alarm. Mr. Boulard thanked everyone. He said throughout the month of May they will reach out through social media to get the message out that this program is available.

2. Beautification Commission Update – Sheryl Walsh-Molloy, Director of Community Relations and Wendy DuVall, Community Outreach & Event Specialist

Sheryl Walsh thanked Mayor and Council for the opportunity to discuss this. She said it has been 6 months since the Beautification Commission transitioned to the Community Relations. They were excited about the opportunity to oversee the Homeowner's Associations, business relations, and community relations among residents. She added

that it was a great opportunity to expand the Commissions horizons and look at what programs they had offered in the past and start to step out of the box to be more progressive with their offerings. She said it was a great fit for Wendy DuVall, who was just certified as a Master Gardener. She said there were many events and this was a great opportunity for the Beautification Commission to get involved. Wendy DuVall said as of April 9<sup>th</sup> they have a full Commission. The first project was the evaluation and selection for recipients of the Neighborhood Entryway Enhancement Matching Grant Program. They awarded grants to four of the six applicants. They also plan to partner with area businesses, churches, community groups and individuals to establish an "Adopt a City Entryway Sign" program which would have guidelines similar to the Adopt-a-Highway program. They also will create a holiday decorating contest for subdivisions and businesses. They also want to create an object painting contest for the 50th Anniversary celebration. The Commission will play a major role in the "CARES" days. She said they are researching a National Wildlife Federation Community Habitat Certification program which is basically focused on keeping small animals and pollinators in the community. She said they have a good group of diverse members and they are excited to get to work.

## MANAGER/STAFF REPORT: None

#### AUDIENCE COMMENT:

Michel Duchesneau, 1191 South Lake Drive, was present to talk about the setback requirements for 3 story buildings that require a RM-2 zoning without use of overlay. He said the requirements would be similar whether you use an overlay or not. In essence he wanted to point out was the Zoning Ordinance for a 3 story townhouse it would clearly be a RM-2 district. The setback requirements per the chart are 75 foot for the front, rear, and side yards. He said there was a proposal that the City was evaluating to build townhouses south of 13 mile along Old Novi Road. He said there were three parcels being reviewed. He said the first parcel was 100 feet deep and cannot meet the setbacks. The second parcel was a wooded lot and had 144 feet of frontage and was 200 feet deep; it also cannot meet the setbacks. The third parcel had 265 feet of frontage and was 200 feet deep. Once you factor in the setbacks there was only an area of 115 feet by 50 feet that could be built upon while meeting setbacks. He said the area in question would clearly not be appropriate when considering the intent of a RM-2 district.

Karl Migrin, 49450 9 Mile Road, said he supports Agenda Item 2 that makes changes to the Woodlands Protection Ordinance, but in reading through this ordinance, he noted that it does not encourage developers to transplant native species found within the boundaries of their development. It is easy for a developer to clear cut any trees, but with the current shortage of replacement trees 2.5 cinches and above, he believes developers should be encouraged to relocate any smaller trees somewhere else on the property. When he built his home in 1987, he relocated several Silver Maple trees. He said they all survived and he was even able to transplant two to other properties. Dorothy Duchesneau, 125 Henning, thanked Council for their hard work. She wanted to address Agenda Item 3. She said Goose Busters is an excellent organization; they are humane to the geese and effective in deterring geese. She would like to see the City add the wastewater treatment plant and the shores of Shawood Lake to the program. She explained that the objective is to destroy the nest and eggs during the 2-3 weeks that a female cannot relay eggs is. It has to be something that harasses the goose and makes them go somewhere else. Geese can live up to 25 years without a natural predator. She said where they are born is where they come back to and where they will nest for the rest of their life. Other things like dogs, noises, sparkly objects don't work but destroying the nest does work. It can be done humanely. She asked that they consider adding some of the Novi property to the target zones.

2. Member Mutch asked Rick Meader about encouraging developers to transplant trees. He questioned whether the City has a policy in terms of how we handle those situations and if we encourage it and if he thought it was effective. Mr. Meader said he had not seen that in the ordinance and it's never come up as a suggestion. Member Mutch asked if it was a viable option for certain sites instead of clearing all trees. Mr. Meader said it would be viable with small trees, but would be cost prohibitive with big trees. They would also need a place to put them during the transplantation process. Member Mutch said the language doesn't address the developer getting credit for saving a native tree. He felt it would be worth adding language prior to the second reading to give a developer credit for keeping trees on site and discourage clear cutting. Member Mutch commented that the changes were necessary and good changes. It discouraged certain tree species that don't fit in Michigan so people will use native plants. He said in terms of the Woodland Ordinance overall, he wanted staff, consultants, and the Planning Commission to recognize it is a woodlands protection ordinance not a replacement ordinance. He said we want to protect trees not just replace them.

Member Breen said she couldn't support this item. When she read the DNR materials it indicated a number of measures must occur before destroying the eggs and nest. She said we don't know what other measures have been taken by the applicant. She said she can't support the destruction of wildlife. She understands they are invasive but she cannot support without knowing what other measures have been undertaken.

Member Mutch said they are invasive and they have taken over. He can support this and explained that their role isn't to validate whether the applicant has done all necessary steps to receive DNR approval. He looks to DNR to do the appropriate review with the applicant to ensure they've followed all the steps. Their role is administrative and to acknowledge they are aware and accept the concept of the nest destruction. He said it has been a controversial topic, but this is the least destructive and most humane way to deal with the goose problem.

Mayor Gatt said he has learned that anything and everything to do with animals is controversial. He said the DNR has very prohibitive fines and sanctions for those who break the rules.

Mayor Pro Tem Staudt asked about the PEG fees having an offset from Cable Franchise Fees. He asked how Cable Franchise Fees were involved with PEG fees. He said he understood there could be an increase in PEG fees but he didn't understand why Cable Franchise Fees could affect this line item. Carl Johnson said it must have been the wording because they are separate. Cable Franchise Fees are in the General Fund and PEG fees are in the PEG Fund. Mayor Pro Tem Staudt asked that the wording be corrected.

## AUDIENCE COMMENT:

Todd Keene, 2300 Austin Drive, said he has lived in Novi for 25 years. He wanted to speak about the townhomes at Pavilion Shores. He said there has to be a better way to fulfill the needs and wants of the City of Novi other than letting a developer build apartments in their backyards. He said he didn't know where any of the Council members live but he was certain that not one of them would like the same thing in their backyard. He asked that any time something related to this development comes before them, to please step in their shoes.

Karl Migrin, 49450 9 Mile Road, said he sent them two presentations in the mail dealing with the proposed developments in the southwest section of the City and the impact they will have on wetlands, woodlands, and wildlife. He said he spent many days creating these presentations and asked they take time to review them. He said he didn't know when the project will come before Council but he wanted them to have the information. He appreciated them taking the time to look it over.

### MAYOR AND COUNCIL ISSUES:

Member Markham said she lives in zip code 48374. She said about six to nine months ago, the Post Office changed the distribution from Novi to Walled Lake. When that happened, the service declined precipitously. She said she consistently receives material a day later than everyone else. She said the other residents in the zip code have complained as well.

Mayor Gatt said his zip code is 48375 and his tax return was mailed February 2<sup>nd</sup> but he just received it today. He said they need to keep in mind they have no control. He has noticed a large decline in service as well.

Member Markham said the biggest inconvenience is that they have to travel into Walled Lake instead of going to the Novi Road location.

Mayor Gatt requested administration work through our members of Congress to see if they can help.

Mayor Pro Tem Staudt said several years ago the mailing standards changed. First Class went from 1-2 days to 2-4 days. In this case he advised residents to call the Metroplex and talk to a postal supervisor there. He said it's not a local problem; it's a result of the distribution process.

Member Breen said the 48377 zip code has encountered problems as well. She has heard reports of missing mail, prescription drugs and boxes of checks disappearing.
