SUBJECT: Approval to award the construction contract for 2018 Chip Seal program to Highway Maintenance and Construction Company, the low-bidder, in the amount of \$130,660.03.

BACKGROUND INFORMATION:

The 2018 Chip Seal program is an ongoing effort to rehabilitate Novi's chip seal roads. Chip sealing provides an application of a special protective wearing surface to an existing pavement. There are only a handful of chip seal streets in Novi which typically carry lower traffic volumes. The chip seal program will focus on the following local roads:

- Brenda Lane
- Joseph Drive
- Burton Drive

- Delmont Drive
- Dinser Drive

The low bidder Highway Maintenance and Construction Company included a letter with the bid indicating their schedule was booked and they are not able to complete the work by the seasonal limitation date of September 15. Highway Maintenance agreed to do the patching preparation in 2018 and complete the chip seal application in the spring of 2019.


AECOM, the City's Engineering Consultant, assisted the Engineering Division with developing the plans for this project. Staff advertised the plans for public bids on June 13, 2018. Following the solicitation period, one (1) bid was received and opened on June 28, 2018. Highway Maintenance and Construction Company's bid is recommended as being in the best interest of the City as it is responsive and complies with all of the requirements of the bidding instructions. Attached in the packet are the award recommendation letter and bid tabulation. The summary of the bid tabulation is as follows:

*Crew Days are included to compare bids, but are not included in the award.

The construction engineering services award associated with this project is proposed elsewhere on this agenda. It is anticipated the project will be substantially complete in the spring of 2019.



Dear Mr. Akers:

Attached is the Bid Tabulation for the above referenced project. One bid was received and opened from Highway Maintenance and Construction Company on June 28, 2018. Highway Maintenance and Construction has been the only bidder on chip seal projects for the City in the past. The work requires specialized equipment and although there are other contractors that do this work, Highway Maintenance is the closet one and other contractors have been unwilling to travel outside of their specific areas to bid on the work.

No irregularities were noted in the bid and the bid of \$137,660.03 is 8.8% under the Engineer's Estimate. Highway Maintenance and Construction and performed well on past chip seal projects for the City and their bonding company rating exceeds the minimum A.M. best rating.

Highway Maintenance included a letter with their bid stating that they are not able to complete the work this year as the work must be completed by September 15 due to seasonal limitations. Their crew is scheduled for other projects until then. They agreed to do the chip seal work in the spring with the patching preparation work completed this year.

We recommend award of contract to Highway Maintenance and Construction Company for the bid amount, excluding crew day costs, of \$130,660.03.

The City's intent is to award to the lowest responsible bidder. Funding for the project is limited and the City may elect to eliminate roadways from the contract, reduce the length of roadways included in the project, or potentially add roadways with similar work to the project in order to match the available budget.

If the foregoing Bid shall be accepted by the OWNER, the undersigned agrees to enter into the attached form of Agreement within ten (10) days after receiving notice of such acceptance, will furnish the OWNER satisfactory bonds and certificates of insurance coverage, and will complete the Project, at the price and within the time stated in this Bid.

The undersigned further agrees that if the foregoing Bid shall be accepted, work will commence immediately after the Contract has been awarded, the Agreement executed, and a Notice to Proceed received.

Substantial Completion shall be no later than September 14, 2018.

Final Completion shall be no later than September 21, 2018.

The undersigned attaches hereto its Bid security, as required by the Advertisement for Bids and Instructions to Bidders. The undersigned agrees that in case it shall fail to fulfill its obligations under the foregoing Bid, and/or shall fail to furnish bonds, as specified, the OWNER may, at its option determine that the undersigned has abandoned its rights and interests in such Contract and that its Bid security accompanying its Bid; has been forfeited to the said OWNER, but otherwise the Bid security shall be returned to the undersigned upon the execution of the Contract and the acceptance of the bonds.

The undersigned also agrees that for each and every calendar day that he may be in default of any of the completion dates listed above, the OWNER will suffer a damage of Six Hundred Dollars (\$600.00) per day, and said OWNER shall be compensated therefore at the rate as liquidated damages in accordance with the Agreement.



In submitting this Bid, it is understood that the right is reserved by the OWNER to accept any bid, to reject any or all Bids, and to waive irregularities in bidding in the interest of the OWNER.
