SUBJECT: Approval to procure a Caterpillar Model CB22 Vibratory Asphalt Compactor, from Michigan Caterpillar, Inc., using the State of Michigan (MiDeal) cooperative purchasing contract, in the amount of \$35,342.

BACKGROUND INFORMATION: The Novi City Council approved funding for the purchase of a new vibratory roller in the fiscal year 2012-2013. This machine would allow staff to perform a wide variety of roadway maintenance tasks, and its procurement would eliminate the need to rent similar equipment each year (see attached photo).

Procurement of the vibratory roller would provide DPS staff members the ability to schedule roadway maintenance as required by service priority, rather than scheduling work around the availability and restrictions associated with rental equipment. This machine would allow staff to extend "summer maintenance" asphalt repairs to as many as seven months (previously limited to as little as three months due to local equipment demand during the construction season). The vibratory roller's versatility would provide staff the ability to compact stone and multiple layers of asphalt greater than two inches, and to correct athletic field imperfections.

DPS currently rents a vibratory roller for approximately \$2,000 per month and up to seven months annually. Based on the estimated rental time required for annual repairs, the payback period for this machine would be 2.5 years.

The pricing is based on the State of Michigan's MiDeal cooperative purchasing contract with Novi-based Michigan Caterpillar, Inc. for a Caterpillar Model CB22 vibratory asphalt compactor, see attached quote and MiDeal document(s). Delivery is expected in May 2013.

RECOMMENDED ACTION: Approval to procure a Caterpillar Model CB22 Vibratory Asphalt Compactor, from Michigan Caterpillar, Inc., using the State of Michigan (MiDeal) cooperative purchasing contract, in the amount of \$35,342.
