#### BACKGROUND INFORMATION:

The Police Department provides various services separate from processing FOIA requests for public records for which it passes on its costs to the user of the service including, fingerprinting, clearance letters, impound release, paper license plate replacement, paper driver's license replacement, and replacement of lost citations.

The fees for fingerprinting are consistent with those authorized to be charged by the Michigan State Police pursuant to MCL 28.273. The other fees, though not based on a particular statute, are fees for a service rendered to a particular individual and are proportionate to the cost incurred by the Police Department for providing the service and are therefore consistent with the definition of a fee (rather than a tax) pursuant to state law.
