SUBJECT: Approval of a Resolution amending the membership of the City Council Cultural Arts Committee.

KEY HIGHLIGHTS:

- This resolution supports the change to Council Rules to update the membership from 5 members to 7 members.
- The two additional members appointed to expand the Committee shall initially serve terms expiring December 31, 2027, and December 31, 2027, respectively.

BACKGROUND INFORMATION:

The City Administration believes that, based upon the general discussion at the time of the creation of this body, the proposed amendment to change the Council Rules to increase the membership of the City Council Cultural Arts Committee from five (5) to seven (7) members is consistent with the intentions of the Rules Committee and Council, and this proposed amendment is being presented without having first been formally submitted to the Committee. The two additional members appointed to expand the Committee shall initially serve terms expiring December 31, 2027, and December 31, 2027, respectively. The existing terms of current members shall remain unchanged.

RECITALS:

WHEREAS, the City Council established a City Council Cultural Arts Advisory Committee on May 6, 2024; and,

WHEREAS, the City Council Cultural Arts Advisory Committee consists of five (5) members, appointed by the Mayor with the approval of City Council; and,

WHEREAS, the Council believes that the Advisory Board has over the years provided great insight and information to the PRCS Commission and Department, but that the City Council could benefit from similar services, advice, and assistance directly to the City Council.

NOW, THEREFORE, BE IT RESOLVED that the Committee shall have seven (7) members, appointed by the Mayor with the approval of City Council. Membership is unrestricted; however, an attempt will be to identify residents with art backgrounds (e.g.,

art educators or artists) in order to better support the mission of the Committee. To establish and maintain staggered terms, the two additional members appointed to expand the Committee from five (5) to seven (7) members shall initially serve terms expiring December 31, 2027, and December 31, 2027, respectively. The existing terms of the five (5) current members shall remain unchanged. Thereafter, all appointments shall be for two-year terms.
