John E. Enkemann said he is an architect with the firm of Albert Kahn Associates in Detroit, Michigan. He has been a member of the Construction Board of Appeals since 1993 and Chairman since 1996. He would like to be considered for the position even though they didn't have a meeting last year. He noted that is a good thing as that means no one had an appeal. Members Margolis, Mutch, Wrobel, Casey, Mayor Gatt, and Mayor Pro Tem Staudt thanked him for his service and didn't have any questions.

Ramesh Verma said he has lived in Novi for thirty-five years. He has been serving on the Library Board for the last five years. He wished to continue because he enjoys what he is doing. He felt the Trustees are very dedicated. He wants to work with them. At the same time, his professional experience is in construction and that is why he wanted to volunteer for the Building Authority. He wanted to work with the City staff members in the Building Authority. Member Mutch was familiar with the work he has done on behalf of the City and asked what he was looking to accomplish and the biggest challenge for the Library in the next few years. Mr. Verma explained that when he joined, it was during the design and construction of the new library. He felt increasing revenues were the challenge for the Board. The Board is working on the Budget. They have been using Fund money to help. At the same time, the Staff has not received any raises in the last three years. He is looking forward to working with the Board. Mayor Pro Tem Staudt said he would support his re-appointment but would like to see a greater effort made by the Library Board to continue to offer the maximum number hours possible to be open. It is important to the Community. Mr. Verma said it was discussed at a meeting recently. They will work on it. Member Wrobel thanked Mr. Verma for his service. He asked Mr. Verma what skills he thought he brought to the Library Board and how does he use them to help the Library Board move forward. Mr. Verma said his skills are in management administration because during the construction of the new Library, his expertise was working on the design and construction. He has been in a leadership role for almost thirty-five years. He works closely with the Trustees and Directors on the budgets. The warranties are over so he works with the facilities staff, also. Member Casey said she had no questions for Mr. Verma and had the pleasure of serving with him on the Library Board for several years. She is aware of his dedication and skills. Member Margolis and Mayor Gatt had no questions and thanked him for his work and continued service. Mr. Verma noted that he read that the Chamber of Commerce was creating international networking to bring ethnic people to Novi. He suggested an ethnic ambassador helping Staff and the Chamber of Commerce.

AUDIENCE COMMENT – James Courtney, 22144 Roberts Drive, was there representing groups; Bella Terra Subdivision, Kirkway Subdivision, and Park Place Estates. He is the President of Park Place Estates Homeowners' Association. He asked the City to consider paving Napier between Nine Mile to Ten Mile and looking at the intersection at Ten Mile and Napier. He felt the project would provide immediate benefits to the Community in the form of improving the safety of the intersection that has a high speed and low visibility. It would alleviate traffic at the Eight Mile and Beck intersection. It would benefit two projects that are proposed; Lyon Township at Ten and Napier that will have sixty-one, one-acre lots and at Nine Mile and Napier where the David Barr Park will be

created. The paving project is necessary for safety concerns for emergency services that cannot travel on a dirt road. It would be in coordination with Oakland County Road Commission, Lanny Young, Lyon Township and Brian Coburn, City of Novi Engineering Manager. He asked City Council to consider the request to benefit the resident's safety and the surrounding communities.
