BACKGROUND INFORMATION:

A sanitary sewer Capacity Management, Operations, and Maintenance (CMOM) program was initiated by the City in 2005 as a multi-phased program to perform long-range planning, improve operation and maintenance of the system, and ensure the integrity of the sanitary sewer system. One of the key components of the CMOM program is the evaluation of the sanitary sewer infrastructure to determine areas that require repair – primarily to prevent infiltration and inflow of clean water (i.e., groundwater and storm water run-off) from entering the system and being unnecessarily treated at the Detroit wastewater treatment plant. Infiltration and inflow that enter the system will increase treatment costs and decrease available capacity.

Over the past several years, the Water and Sewer Division has cleaned and televised these areas to identify defective segments of pipe that are in need of repair. The scope of this project included the rehabilitation of the areas identified by Water and Sewer staff in three areas within the City, identified as Areas B, C1, and G (see attached location map). To put the rehabilitation effort into perspective, the contractor for this project, Inland Water Pollution Control, Inc., rehabilitated roughly one-third of the City's sanitary sewage collection system network with this project, which was awarded by Council on August 27, 2012 in the amount of \$553,441.

Engineering staff worked with the engineering consultant for this project, Spalding DeDecker Associates, Inc., to review and verify the final contract payment amount of \$27,214.98 that is due the contractor (Final Pay Estimate No. 3, attached). The City Attorney reviewed the documentation and found it to be in an acceptable form (Beth Saarela's October 29, 2013 letter, attached).


There were two approved change orders for this project resulting in a net increase of \$55,458 to the construction contract or 10.0% over the awarded amount. The first change

order added two more segments of pipe which upon further investigation found foreign intrusions into the pipes and required grouted sleeves to bridge the repair. This change order increased the contract by \$27,014. The second change order balanced original quantities and added scope of work for raising an existing manhole out of a wetland which increased the contract by \$28,444. The approved change orders resulted in a final contract price of \$608,899.

RECOMMENDED ACTION: Approval of the final pay estimate to Inland Waters Pollution Control, Inc. for the Sanitary Sewer Rehabilitation in CMOM program areas B, C1, and G in the amount of \$27,214.98.

Inland Waters Pollution Control, Inc, ("Inland Waters") as general contractor for the City of Novi Sanitary Sewer Rehabilitation Contract – Areas B, C1, and G (the "Project"), subcontracted with Interstate Landscaping & Consulting ("Interstate") for restoration for the project. Interstate completed its work under the subcontract and invoiced Inland Waters for the total amount due of \$ 67,497.00, on October 10, 2012. On November 1, 2012, Inland Waters issued check no. 183738 to Interstate, which check was cashed by same on November 8, 2012, in full satisfaction of all amounts due with respect to the Project.
