BACKGROUND INFORMATION:

On August 12, 2013, City Council approved two resolutions amending the good faith offers to the owners of parcels 22-27-200-010 and 22-27-200-012. Though the total amount of just compensation will remain the same, the property owner has requested that the previously approved just compensation of \$10,000 be reallocated between the two parcels pursuant to a settlement agreement between the parties. The reallocation will not change the rights or obligations of the City with respect to the easements. See attached letter from City Attorney dated August 21, 2013.

RECOMMENDED ACTION: Approval of a corrected and revised Good Faith Offer in the amount of \$10,000 for two permanent pathway easements over parcels 22-27-200-010 and 22-27-200-012 to be allocated between the two parcels pursuant to the agreement of the parties for the purpose of constructing a pedestrian safety path on the west side of Novi Road between Nine Mile and Ten Mile.

Dear Mr. Croy:

As you know, on August 12, 2013, City Council approved a counter-offer in the amount of \$10,000.00 to the City's good faith offers in the amount of \$1,632.00 (Parcel No. 50-22-27-200-012) and \$854.00 (Parcel No. 50-22-27-200-010) for two safety path easements and temporary grading permits over his property. The counter-offer was allocated to the two parcels in the same proportions as the original good faith offers. The property owner has requested that the amount of the counter-offer remain the same but be reapportioned between the two parcels in different amounts based on a settlement agreement between the parties. Except for a potential increase in transfer taxes (approximately \$25.00) resulting from the reallocation of amounts previously attributed to the grading permits, we see no disadvantage to the City in the reapportionment.
