# **BACKGROUND INFORMATION:**

This Quit Claim Deed is associated with the Warranty Deed accepted by City Council on January 8, 2018, which included the dedication of 43-foot master planned right-of-way along the west side of Taft Road. The aforementioned parcel also has frontage along 12 Mile Road, which is under the jurisdiction of the Road Commission for Oakland County (RCOC). The 60-foot master planned right-of-way along the north property line needs to be dedicated to the RCOC, which they are willing to accept. If approved by City Council, the Quit Claim Deed would be presented to the Board of County Road Commissioners for formal acceptance.

The enclosed letter by the City Attorney (Beth Saarela, October 24, 2018) provides the Quit Claim Deed that was prepared for this dedication and is recommended for acceptance.
