#### BACKGROUND INFORMATION:

The City recognized the need and planned for the rehabilitation of Thirteen Mile Road from Novi Road to Meadowbrook Road. The proposed work initially identified by the City included milling and filling the existing asphalt road. The geotechnical investigation identified peat and other organic material present in the subgrade, and therefore, recommended reconstruction for a portion of the project limits. The geotechnical investigation confirmed the mill and fill rehabilitation for the remainder of Thirteen Mile Road. These proposed road repairs project a 15-year minimum service life.


Consulting Engineer Spalding DeDecker assisted the Engineering Division developing plans for this project. Staff advertised plans for public bids on March 28, 2018. The City received and opened five (5) bids on April 25, 2018. Hutch Paving Inc.'s bid is recommended in the best interest of the City, as it is responsive and complies with all of the requirements of the bidding instructions. The award recommendation letter and bid tabulation are attached for review and reference. The summary of the bid tabulation is as follows:

The construction engineering services award associated with this project is proposed elsewhere on this agenda. Staff is seeking approval to award the project on this agenda, in order to facilitate construction when the funds become available at the start of the fiscal year (July 1, 2018). Estimated substantial completion for the project is before the fall school semester starts.

Dear Mr. Akers:

On April 25, 2018 at 2:00 p.m., construction bids were opened and publicly read at the City of Novi Civic Center for 13 Mile Road Reconstruction. The project consists of reconstruction of 0.6 miles of 13 Mile Road, including HMA surface and base removal and replacement, milling and HMA overlay, and new HMA construction in lane extension areas.

The City Clerk's office received five (5) sealed bids for this project, with each bidder considered to be responsive having submitted a bid compliant with all requirements. The apparent low bidder, Hutch Paving, submitted a total bid of \$472,539.90. Following the bid opening, Spalding DeDecker reviewed all of the bids received, verified the calculations, and prepared the bid tabulation for the project (attached).

Based on a review of experience and references, Spalding DeDecker finds that Hutch Paving is qualified to perform the required construction.

It is our recommendation that the project be awarded to the low bidder, Hutch Paving, for the 13 Mile Road Reconstruction in the amount of \$462,039.90, which is the total bid of \$472,539.90 minus \$10,500.00 for crew days bid.

Upon award by the City Council, our office will coordinate the completion of the Contract Agreement, Bonds, and Insurance information with Hutch Paving.



its Bid; has been forfeited to the said OWNER, but otherwise the Bid security shall be returned to the undersigned upon the execution of the Contract and the acceptance of the bonds.


