BACKGROUND INFORMATION:

This project was a combination of two separate line items in the Capital Improvement Plan: 1) Civic Center North Parking Lot Improvements and 2) Power Park Pathways Rehabilitation.

Improvements to the north Civic Center Parking Lot included pavement replacement in areas that had shown significant deterioration, and crack repair and patching in other areas.

In Power Park, there was approximately 1,500 feet of asphalt pathway that had shown varying levels of deterioration. The original plan was to perform crack repairs on the portions of pathway that were in fair condition, while rehabilitating other areas by way of an asphalt overlay. At the time construction was to begin, further inspection revealed that an overlay would not be the prudent fix. It was determined and agreed to that the rehabilitated areas should be fully reconstructed. Therefore, those rehabilitation portions of pathway were deleted from the contract. The Parks, Recreation and Cultural Services Department will release a future project entailing a reconstructed effort when more funding becomes available.

The construction contract was awarded for this project at the May 11, 2015 City Council meeting to Nagle Paving Company in the amount of \$96,006.00.

Engineering staff worked with the engineering consultant for this project, URS Corporation, to review and verify the final contract payment amount of \$12,000 that is due the contractor (Final Pay Estimate No. 3, attached). The City Attorney reviewed the documentation and found it to be in an acceptable form (Beth Saarela's February 2, 2016 letter, attached).

There were two (2) approved change order issued for this project resulting in a net decrease of \$19,263.50 to the construction contract, or 20.1% under the awarded amount. Most changes were a result of decreased quantities due to removing the areas of pathways in Power Park that are to be reconstructed in the future and balancing of originally projected amounts. The approved change orders resulted in a final contract price of \$76,742.50.

RECOMMENDED ACTION: Approval of the final payment to Nagle Paving Company for the Civic Center North Parking Lot and Power Park Pathways Rehabilitation project in the amount of \$12,000, plus interest earned on retainage.
