Today is Tuesday, August 11, 7:00 p.m. 7 8 And, Katherine, can you please call for the roll call. 9 10 MS. OPPERMAN: Yes. Certainly. 11 All right. Member Krieger? 12 MEMBER KRIEGER: Present. 13 MS. 19	Jim Ascencio, A-s-c-e-n-c-i-o, Maudlin Street, west of
20	Old Novi Road and south of South Lake Drive, Parcel
21	Number 50-22-03-453-011. The applicant is requesting
22	the variance from the Novi Zoning Ordinance Section
23	3.1.5 for a 9-foot variance for 16-foot aggregate total

Page 8 1 side yard setback, 25 feet required. A four percent 2 increase of lot coverage for a total proposed lot coverage of 29 percent, 25 percent allowed by code. 3 These variances will accommodate the building 4 5 of a new home. This property is zoned single family 6 residential, R-4. This case was originally heard July 7 14 and now it is tabled. The applicant is present, please? 8 MS. OPPERMAN: Pardon me, Joe. There was an 9 10 amendment to the agenda. I'm not sure maybe if you're looking at the older version. They are now requesting 11 12 lesser variances. The only variance they are 13 requesting is from section 3.1.5 for a separate variance for a 21-foot aggregate total side yard 14 15 setback, 25 feet required. 16 CHAIRPERSON PEDDIBOYINA: Oh, 21 feet? MS. OPPERMAN: 21 feet is now what they're 17 requesting. So a four foot variance. 18 19 CHAIRPERSON PEDDIBOYINA: Okay. Four feet 20 variance. Sounds good, thank you. 21 Is the applicant is present, please? 22 (No response.) 23 CHAIRPERSON PEDDIBOYINA: Call one more time.

Page 9 1 Is the applicant present, please? 2 MS. OPPERMAN: That would be you, 3 Mr. Cummings. MR. CUMMINGS: Oh, I am present, sir. Robert 4 5 Cummings. 6 CHAIRPERSON PEDDIBOYINA: All right. Thank 7 you, Robert. I appreciate it. Sounds good. And we 8 can move on that. Are you an attorney? Thank you. 21 CHAIRPERSON PEDDIBOYINA: 22 Thank you, Katherine. 23 Thank you so much, Robert. I appreciate.

Page 10 1 And you can move and you can present your case, sir. 2 Thank you. 3 MR. CUMMINGS: Thank you. Mr. Chairman, board members, city officials and neighbors, I wanted 4 5 to thank you for your time tonight on this project. 6 We'll be reviewing the time from last July until 7 tonight. 8 My name is Robert Cummings. I am 9 representing Jim Ascencio for this matter on Lot 46, 10 Idamel Park (ph). Tonight I will show how we listened to all 11 12 the persons that I mentioned and we will deliver a plan 13 to build a residential home taking all into 14 consideration. Tonight we are here requesting one 15 variance. And that is 25 foot total, two sides. We 16 have lowered our request from nine feet to four feet in 17 That is a 125 percent lower request. that area. We 18 have placed the house as central as possible. We have 19 10 feet on the south side of the property and 11 feet on the north side of the property line. 20 Discussed last time was a garage issue and I 21 22 hope that persons will consider in the city of Novi a 23 garage as an aesthetic. It's a place to store your

Page 11 1 snow blower, lawnmower and garbage cans. There are 2 garages in close neighbors at 118, 124 and 133 Maudlin. We have submitted within the last, late July, 3 our new drawings where we have went from a basement to 4 5 a crawl space. With this, our overdig will be as 6 minimum as possible and also this will be less 7 disturbance to any tree area on the south side of the 8 project. We are hiring a builder that has been building in the city in the area for over 30 years. 9 10 His name is Matt Thurber of Evergreen Development. And 11 I am sure that the highest percentage of people that work in the building department will give him a high 12 13 grade. There was some communication of water 14 15 drainage in our last meeting and the new survey that 16 was submitted in late July will show that all the water 17 will drain to the back of the east part of the 18 property. 19 In letters of opposition from our July meeting, there was in discussion with neighbors six 20 21 individuals who had presented letters. They were 22 133 Maudlin, Victorian Garden business, Sherman Builder 23 business, Dynamic Wall business, 118 Maudlin and

Page 12 1 130 Maudlin. They stated that they were not happy with 2 four feet from the south property line to the house. We are not asking for any variance of that area because 3 we meet the setback and, again, our distance is 10 feet 4 5 from the south property line. 6 In a letter, a neighbor had communicated that 7 the deer and the cranes could not have ample space to 8 pass. Well, there's going to be at least 50 feet on 9 the east and the west side of the property, with 25 10 feet on the north and south. And I think we all can reasonably agree that deers and cranes will have room 11 to roam freely. 12 13 We have spoken with the neighbor to the north at 123 Maudlin and he has told me he is in favor of our 14 15 project. He has told me that in the last week he has submitted a letter and in that letter he will tell of 16 17 how our project will beautify the street of Maudlin. And in a conversation, a brand new home will grace and 18 19 beautify the street and it will add property values to 20 the neighborhood. I want to thank everyone for your 21 time this evening. 22 CHAIRPERSON PEDDIBOYINA: Thank you very 23 much, Robert. A nice presentation.

Page 13 1 Is there anybody who would like to speak on 2 behalf of you on this case? 3 (No response.) CHAIRPERSON PEDDIBOYINA: Robert? 4 5 MR. CUMMINGS: Say that again, sir. 6 CHAIRPERSON PEDDIBOYINA: Is there anybody 7 else who would like to speak on this case? 8 MR. CUMMINGS: No, sir. 9 CHAIRPERSON PEDDIBOYINA: No. Okay. Thank 10 you so much. Secretary Katherine, would anybody ... 11 Thank you for that. And let's move on 12 Okay. to the first case regarding the person. 13 From the City, Larry, anything? 14 15 MR. We sent out a 20 second mailing as a courtesy to the neighbors. There were 52 letters sent. Two returned. We did receive 21 22 one disapproval. Objection rather. From the neighbor 23 at 133 Maudlin once more just stating they're still

Page 14 1 very concerned of the tree line and extremely concerned 2 with drainage issues. They ask that, you know, please build a house that follows the rules. And that she 3 believes that a suitable house can be built that still 4 5 follows the rules created by the City. 6 That was Tina Ziegler at 133 Maudlin. 7 CHAIRPERSON PEDDIBOYINA: Okay. Thank you 8 very much, Katherine. 9 And thank you, Mr. Larry, for the 10 communication. Anybody for public remarks? Anybody you can 11 12 see on this, Katherine? 13 MS. OPPERMAN: I don't see that anyone's raising their hands. 14 15 CHAIRPERSON PEDDIBOYINA: Okay, sounds good. 16 Thank you so much. 17 And okay, let me put it on the board and see. 18 And then I'll speak on the case. It's open to the 19 board if anybody would like to speak on this case, 20 please, you can talk. It's open for the board. 21 Linda, are you there? 22 Linda? 23 Is she muted or what?

I think that centering the house and getting 4 5 the setbacks more reasonable on the side. And also 6 noticed that the crawl space was turned into what I 7 would consider a crawl space. It's only five foot now 8 and not what it was before. 9 So thank you, Mr. Cummings. And to your 10 owner for listening and working this out. I think you 11 did a good job, and I would be in support of it now, 12 too. 13 CHAIRPERSON PEDDIBOYINA: Thank you so much, Mr. Board Member. 14 15 Any other board member, please? MEMBER SANKER: Yeah, I'll just make a quick 16 17 Hey, how's it going, guys? comment. 18 CHAIRPERSON PEDDIBOYINA: Okay, go ahead, 19 please. MEMBER SANGHVI: Yeah, well, I just want to 20 21 reiterate what the previous board members have said. Ι 22 think the petitioner did a lot of work and was very 23 considerate of listening to the neighbors and trying to

I have no objection. 23 CHAIRPERSON PEDDIBOYINA: Any board member

Because the petitioner has shown practical difficulty requiring this variance. 11 12 Without it, the petitioner is unreasonably 13 prevented or limited with respect to the use of the property because he will not be able to build a house 14 15 of appropriate size to live in. 16 The property's unique because it's narrow. 17 The petitioner did not create the condition because he 18 purchased the property in its narrow condition or 19 narrow shape and size. And the relief granted is not -- will not unreasonably interfere with adjacent or 20 21 surrounding properties because they centered it, the 22 structure, as much as they could in the middle of the 23 property and have used a minimum variance request in

So it was important to me to 8 kind of just -- I thought our community really needed it and I just left my clientele in Birmingham and came 9 10 here in Novi to open up the store. Long story short, I found an opportunity in 11 2010 two doors down to open up Salon Freda. 12 So with 13 that being said, I have two of the businesses here in Novi and was building a strong, global community online 14 15 with all the different social media platforms as well 16 as our online stores and all the different ways that we 17 can, you know, connect with clients now. So with that being said, I decided to put 18 19 both -- just more out of convenience and control. Just 20 to put everything under one roof. So I took the salon space, which is -- technically, it would have been two 21 22 suites, but I kept it -- I just didn't use the wall 23 separating the two business, but they are separated.

Page 24 1 If you were to walk in, there's two doors. And I put 2 everything under one roof. So I'm really asking for me to be able to 3 move the Faces by Freda sign over to stand over the 4 5 Faces by Freda door. And it's just -- it's really 6 important because we have such a huge clientele that 7 come from out of town. Not just from out of town, but like other cities, surrounding areas. 8 I just took three clients today which were 9 10 from Chicago, Florida and Grand Rapids. And people don't all know that I own Salon Freda and Faces by 11 12 Freda. So some people come looking just for Faces by 13 Freda or Salon Freda. So it's really important for the survival of my business to have both identities on the 14 15 door. 16 CHAIRPERSON PEDDIBOYINA: Anything else you'd like to add? 17 18 (Telephone ringing.) 19 MS. ANSARA: I just hope you really take into consideration the importance of -- you know. 20 21 CHAIRPERSON PEDDIBOYINA: Can somebody can mute their phone, please? 22 23 (Muted.)
