REMARKS FROM THE COMMITTEE CHAIRPERSON:

Councilmember Casey began by welcoming Director Muck back from his vacation. She also congratulated Councilmember Smith on the birth of his grandson.

Member Casey then gave an update on the status of the survey the committee had been working toward. The survey should be live beginning February 20th, and the committee could see results at the next meeting on the 26th.

Councilmember Gurumurthy offered her assistance in facilitating discussions to gain insight into Novi's Asian population and learn about their vision of a senior/community center, housing, and transportation issues. The committee will work with her to arrange these conversations.

MATTERS FOR COMMITTEE DISCUSSION:

1. Housing & Aging in Place

Member Casey opened discussion to ask what the committee members took from the presentation from City Planner McBeth during the meeting on January 29th. Some of the main items discussed were:

- The need for first floor living
- Finding how to address housing for the population in "transition", who are ready to move out of large family homes, but not ready for senior housing.
- Discuss options for subsidized housing.

- Suggest moving away from townhouse style homes to multi-story buildings that contain single story dwellings, elevators, and covered parking.
- Work with Community Development to change the ordinances or planning guidelines to allow for "granny flats", accessory dwelling units, or converting garages into living spaces.
- Incentivize developers to dedicate a portion of new projects to 55+ living spaces.

ROUNDTABLE DISCUSSION: None

AUDIENCE COMMENTS:

Dorothy and Michel Duchesneau voiced their support in favor of moving away from 3-story townhouse homes to ranch style units. Mrs. Duchesneau urged caution when proposing ADU's or granny units to avoid these dwellings becoming rental spaces. Mr. Duchesneau said that he believes that the committee is on the right track, and if City Council and the Planning team remain consistent with their desires, that developers will get on board for more senior friendly housing options in the future.
