The Community Relations Division is putting together the 2017 Annual Report/Calendar for the City of Novi. All city departments have been a sked to forward important dates to incorporate on the calendar.

The attached draft calendar includes suggested dates for the Planning Commission meetings, which are primarily the second and fourth Wednesday of each month, with a few exceptions for holidays and other considerations. The suggested Planning Commission dates are highlighted in blue. City-recognized holidays are indicated in yellow. Please note, for 2017, the Library Board will use to the Council Chambers for its monthly meetings, typic ally scheduled for the third Wednesday evening each month.

For 2017, staff is suggesting one meeting in November and December. Altematively, the Planning Commission may wish to allow for two meetings each month; meetings may be cancelled if there is no reason to meet. It is expected that the Planning Commission meetings will continue at the same starting time of 7 p.m.
