
**SUBJECT:** Acceptance of a donated pathway easement from Island Lake of Novi Community Association for construction of a pathway connection as part of the Safe Routes to School project.

**SUBMITTING DEPARTMENT:** Department of Public Works, Engineering Division

BACKGROUND INFORMATION: The City received funding under the Michigan Department of Transportation's Safe Routes to School (SRTS) grant program to complete sidewalk and ADA improvements at or near six Novi Community School District (NCSD) campuses. The SRTS program is meant to encourage and enable children in grades K-8 to walk and bicycle to school. The City's consulting engineer, OHM Advisors, is designing the project. OHM obtained a pathway easement from Island Lake of Novi Community Assocation at parcel 50-22-18-400-003 to be able to provide a crosswalk connection across Wixom Road just north of 11 Mile Road.

The City Attorney reviewed the signed easement favorably (Beth Saarela, November 13, 2020). Construction is expected to begin in the summer of 2021.

**RECOMMENDED ACTION**: Acceptance of a donated pathway easement from Island Lake of Novi Community Association for construction of a pathway connection as part of the Safe Routes to School project.

Dear Mr. Herczeg:

We have received and reviewed the Sidewalk Easement over property owned by the Island Lake Community Association for construction of sidewalk improvements in connection with the Safe Routes to Schools grant funding. The Sidewalk Easement provided is in the City's standard format and is consistent with the title search for the property.

The Sidewalk Easement may be placed on an upcoming City Council Agenda for acceptance. The funding for the project requires the City to sign the Easement acknowledging acceptance as the Grantee prior to recording. Once accepted and executed by the City, the Sidewalk Easement should be recorded by the City Clerk's Office with the Oakland County Register of Deeds in the usual manner. It is our understanding that the City's Engineering Division has the original Sidewalk Easement for recording.

Grantee may install, repair, replace and maintain lines and all necessary appurtenances thereto, within the easement herein granted.

Grantor agrees not to build or to convey to others permission to build any permanent structures on the above described easement.

The premises so disturbed by reason of the exercise of any of the foregoing powers, rights and privileges, shall be reasonably restored to its prior condition by Grantee.

This instrument shall be binding upon and inure to the benefit of the parties hereto, their heirs, representatives, successors and assigns.


