BACKGROUND INFORMATION:

At the City Council meeting held on May 21, 2018, a long-term use agreement was approved with the Novi Community School District for the property on the west side of Beck Road and the south side of 11 Mile Road that is currently undeveloped and vacant. The agreement allows the City to make improvements and maintain the land as public park land, open for use by the general public, and not for private operation. No indoor recreation is permitted, and no permanent structures are allowed or planned, except for any storage or maintenance structures agreed upon by the City and the School District.

The City plans to use and develop the property, now known as Bosco Fields, for multipurpose sports, athletic, and recreational fields with related amenities. It also includes parking areas and access roads off of Beck Road and off of 11 Mile Road. The final design includes 13 soccer fields of four sizes including: 4v4, 7v7, 9v9, and 11v11.

Spalding DeDecker, the City's Engineering Consultant, assisted the Engineering Division with developing the plans for this project. As of June 2018, construction costs estimates were approximately \$1.47 million. Plans were adjusted to remove the softball/baseball field and add an access road to the southern acreage. This necessitated a change to the field layouts and pathways with estimated construction costs adjusted to approximately \$1.63 million.

Engineering staff advertised the plans for public bids on September 13, 2018. Following the solicitation period, six (6) bids were received and opened on October 12, 2018. Anglin Civil's bid is recommended as being in the best interest of the City as it is responsive and complies with all of the requirements of the bidding instructions. Attached in the packet are the award recommendation letter and bid tabulation. The summary of the bid tabulation is as follows:

The construction engineering services award associated with this project is proposed elsewhere on this agenda. It is anticipated the project will be substantially completed in spring 2019.

The difference between the originally estimated \$1.63 million construction cost and the low bid of \$1.97 million are attributed to the continued rise in construction costs in the area. Staff is proposing bid items related to tree planting and seed/mulch mix be removed from the construction project and allocated as an appropriation from the Tree Fund.

RECOMMENDED ACTION: Approval to award the construction contract for the Bosco Fields project to Anglin Civil, LLC, the low-bidder, in the amount of \$1,931,663.68, and amend the budget.

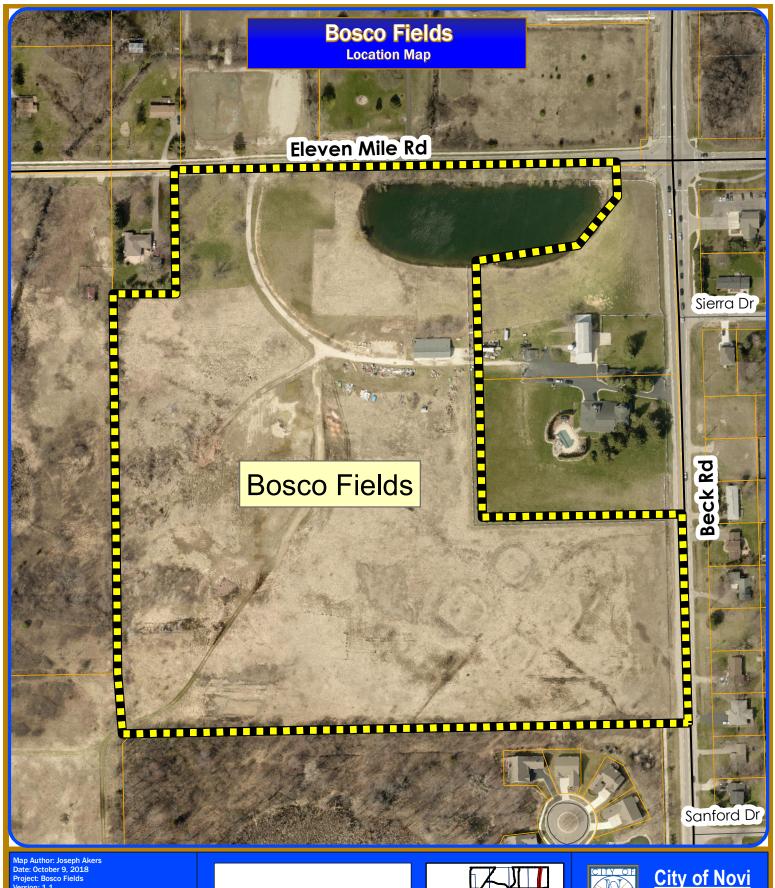

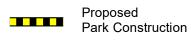

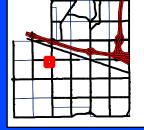

Dear Mr. Melistas:

On October 12, 2018 at 11:00 a.m., construction bids were opened and publicly read at the City of Novi Civic Center for the Bosco Fields project. The project includes preparing soccer fields with irrigation from a new well, parking lot, walking paths, and entrances to Beck Road and 11 Mile Road.

The City Clerk's office received six (6) sealed bids for this project, with each bidder considered to be responsive having submitted a bid compliant with all requirements. The apparent low bidder, Anglin Civil, submitted a total bid of \$1,973,663.68. Following the bid opening, Spalding DeDecker reviewed all of the bids received, verified the calculations, and prepared the bid tabulation for the project (attached).

Based on recent experience on City of Novi projects, Spalding DeDecker finds that Anglin Civil is qualified to perform the required construction.

It is our recommendation that the project be awarded to the low bidder, Anglin Civil, for the Bosco Fields project in the amount of \$1,931,663.68, which is the total bid of \$1,973,663.68 minus \$42,000.00 for crew days bid.

Upon award by the City Council, our office will coordinate the completion of the Contract Agreement, Bonds, and Insurance information with Anglin Civil.

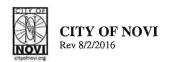
