

# City of Novi City Council December 20, 2021 

SUBJECT: Approval to adopt an Act 51 New Street Resolution accepting Crescent Boulevard (from Adell Center Drive south to Grand River Avenue) and Lambert Drive as public, adding 0.40 miles of roadway to the City's public street system.

SUBMITTING DEPARTMENT: Department of Public Works, Engineering Division

## BACKGROUND INFORMATION:

Following the completion of both Main Street and Market Street, the City of Novi has been working towards connecting a "ring-road" around the Novi Road and Grand River Avenue intersection. A fully functioning ring-road will greatly increase the economic value of abutting properties and time lessen the amount of traffic in and around that intersection.

Since 1997, the City has been acquiring right-of-way along the future alignment of Crescent Boulevard and Industrial Spur (now officially renamed "Lambert Drive") in the northwest quadrant, through primarily the General Filters and Comau International properties.

The City issued the Notice-to-Proceed to its contractor on April 29, 2019, to begin construction of the current Crescent Boulevard and Lambert Drive and officially opened-to-traffic on May 20, 2021. The approximate length of the newly completed and opened Crescent Boulevard and Lambert Drive is 1,425 feet and 663 feet, respectively.

The enclosed resolution satisfies the Michigan Department of Transportation requirement for adding 0.40 miles of roadway to Act 51 funding.

RECOMMENDED ACTION: Approval to adopt an Act 51 New Street Resolution accepting Crescent Boulevard (from Adell Center Drive south to Grand River Avenue) and Lambert Drive as public, adding 0.40 miles of roadway to the City's public street system.
