SUBJECT: Approval of Change Order No. 1 to Penchura, L.L.C. for the provision and installation of Spectator Covers at Ella Mae Power Park to begin on July 1, 2017, in the amount of \$67,201.

BACKGROUND INFORMATION: Ella Mae Power Park is one of the premier softball sites in the area, and has been host to multiple tournaments as well as adult and youth softball leagues. In 2015, the City of Novi hosted the ASA Northern National, where 68 teams participated in the tournament from around the Midwest. Parks, Recreation and Cultural Services (PRCS) staff have received feedback from community groups and tournament organizers identifying the need for dugout and spectator covers to provide players and spectators an extra layer of protection from batted or thrown balls. Based on the identification of these needs, the project was budgeted for \$100,000 in the 2015-16 Capital Improvement Program as part of overall park improvements for Ella Mae Power Park and ITC Community Sports Park. During the 2016-17 budgeting process, it was determined additional funds were needed to add spectator covers. \$108,632 was added to the 2017-18 Capital Improvement Program to continue the project.

Based on the recommendation of PRCS to include spectator covers in a later fiscal year, and the fact Penchura, L.L.C. has agreed to uphold their prices from their original quote, PRCS is recommending adding seven spectator covers to the Penchura, L.L.C. contract.

Penchura, L.L.C. is a privately owned and operated recreation solutions provider located in Brighton, Mich. PRCS has worked with Penchura, L.L.C. in the past. Most recently, for the fully accessible playground located on the south end of the park, as well as the already-installed dugout covers. Penchura, L.L.C.'s proposal included providing private utility location services, shades including delivery cost, installation, receiving of shade materials, a 10-year warranty and free upgrades to a full cantilever if utility locations deem the t-cantilever model unusable in areas.

The project schedule provided by the consultant indicates construction would occur in August, with completion no later than late September.

RECOMMENDED ACTION: Approval of Change Order No. 1 to Penchura, L.L.C. for the provision and installation of Spectator Covers at Ella Mae Power Park to begin on July 1, 2017 in the amount of \$67,201.
